- 6 have approved: Cochise, Coconino, Gila, Graham, Greenlee, Yuma.
- 7 are processing. Two tabled for additional information (Pima, Mohave). Three have indicated that the staff recommendation will likely be supportive (Apache, Pinal, Santa Cruz).
- 2 have declined: La Paz for financial reasons. Yavapai has indicated a willingness to revisit the topic.
