Kennel Grant Recognition Agreement with Friends of Pima Animal Care Center (PACC)

*Purpose:

Friends of Pima Animal Care Center (PACC) received \$5,000 in grants from several individual private grantors as part of its current fundraising campaign, scheduled to run through December 2024. The funds were given to benefit staff and programs at PACC, with the understanding that the County/PACC would acknowledge those grants in accordance with Policy Number C3.19 of the Pima County Board of Supervisors ("The Naming Policy"). The naming requests are the only restrictions for the grants.

*Procurement Method:

Not Applicable.

*Program Goals/Predicted Outcomes:

Pima Animal Care Center (PACC) and Friends of PACC will collaborate to obtain and place naming plaques on 20 dog kennels and 7 cat kennels at PACC. The plaques will acknowledge each individual grantor who contributed to this \$5,000 kennel-recognition grant.

*Public Benefit:

Grants to Pima Animal Care Center (PACC) help enable PACC to continue providing timely service to residents and compassionate care to animals, while working to support public safety, find homes for homeless animals and educate the community about responsible pet ownership.

*Metrics Available to Measure Performance:

Pima Animal Care Center (PACC) uses a software program called Chameleon to track activities and to measure outcomes of animals in its care.

DONATION AND DONOR RECOGNITION AGREEMENT PIMA ANIMAL CARE CENTER WITH FRIENDS OF PIMA ANIMAL CARE CENTER FOR 'KENNEL PLAQUE RECOGNITION CAMPAIGN'

This Donation and Donor Recognition Agreement ("<u>Agreement</u>"), effective as of date of final signature ("<u>Effective Date</u>"), is entered into by Friends of Pima Animal Care Center ("<u>Friends</u> <u>of PACC</u>"), an Arizona nonprofit corporation, and Pima County, a political subdivision of the State of Arizona (the "<u>County</u>").

RECITALS

A. Friends of PACC wishes to donate funds to be used in support of the programs and projects at Pima Animal Care Center ("<u>PACC</u>").

B. In 2017, the County constructed a new facility for animal care, Pima Animal Care Center, at 4000 N. Silverbell Road, Tucson, Arizona, with bond funds approved from Proposition 415.

C. Friends of PACC and the County are collaborating on a comprehensive Campaign (the "<u>Campaign</u>") to raise private charitable gifts to support the ongoing, pioneering programs of PACC.

D. The design of PACC includes spaces that can be used to recognize donors who participate in the Campaign. The County has prepared a plan for the spaces in which to recognize donors and the donation levels associated with them, titled "Donor Recognition Opportunities Chart for the New PACC Facility" (Exhibit A, 1 Page).

E. Friends of PACC has received donations and pledges of \$5,000 to support PACC staff and programs. The Donations were given with the understanding that the County will acknowledge those Donations in accordance with Policy Number C3.19 of the Pima County Board of Supervisors as adopted on July 5, 2016 (the "Naming Policy"), a copy of which is attached in this Agreement (**Exhibit B, 3 Pages**).

AGREEMENT

1. <u>Payment of the Donation</u>. Upon executing this Agreement with Friends of PACC and the County, the County will provide the Donors with an available Donor Recognition Opportunity, namely the County agrees to the naming of 27 kennels (20 dog, 7 cat) (Exhibit C, 1 Page).

2. <u>Use of the Donation</u>. The Donation will be used by Friends of PACC for the purposes requested by the Donors, described above. Friends of PACC acknowledges that nothing in this Agreement obligates the County to expend any funds for the Campaign, other than funds contributed by Donor or other Donors for that purpose.

3. <u>Acknowledgment</u>. In consideration for the Donation, and subject to the restrictions of the County's Naming Policy, the County will acknowledge the Donation by identifying kennels with the recognition detailed in the "Pima Animal Care Center Kennel Plaque Recognition Campaign" (Exhibit C, 1 Page).

4. <u>**Termination of Recognition**</u>. In addition to any rights and remedies available by law, the County may terminate this Agreement and all rights and benefits of donor hereunder, including terminating the Recognition, if the Board of Supervisors determines in its reasonable and good faith opinion that circumstances have changed such that the recognition would adversely impact the reputation, image, mission, or integrity of the County, or PACC. Upon any such termination of this Agreement and/or the Recognition, the County will have no further obligation or liability to Donor and will not be required to return any portion of the Donation already paid.

5. <u>Modification of Recognition</u>. County reserves the right to modify, relocate, replace, or remove the Donor Recognition if the Board of Supervisors determines this is in the public's best interest, or if PACC is severely damaged. The Recognition may cease if PACC is transferred or conveyed by County to another party, closed, deconstructed, destroyed, or severely damaged, significantly renovated, upgraded, modified, relocated, or replaced. If the Facility is conveyed to another party, the County will use reasonable efforts to have the other party maintain the Recognition for the remainder of the twenty (20) years. The County will notify Friends of PACC in advance of any conveyance, modification, relocation, or removal of Donor Recognition.

6. <u>Publicity</u>. For purposes of publicizing the Donation and the Recognition, the County will have the right, without charge, to photograph Friends of PACC or their representatives. Furthermore, the County will have the right, without charge, to use the names, likenesses, and images of Friends of PACC or their representatives in photographic, audiovisual, digital or other form of medium (the "Media Materials"), and to use, reproduce, distribute, exhibit, and publish the Media Materials in any manner, including in brochures, website postings, informational and marketing materials, and reports and publications describing the activities of Friends of PACC and the County. The County and Friends of PACC will not publicize or release the Donors' personal contact information and confidential financial information, except as required by law. The County and Friends of PACC will seek the Donors' approval on printed quotations attributed to them.

7. <u>Notices</u>. Any notice required or permitted to be given under this Agreement must be in writing and be served by personal delivery or by certified mail upon the other party, addressed as set forth below, or to such other address as a party may from time to time designate by written notice to the other parties:

8. <u>Assignment</u>. A party may not assign its rights or obligations under this Agreement without the prior written consent of the other parties, which consent may be withheld in the sole and absolute discretion of the non-assigning parties.

9. <u>Entire Agreement</u>. This Agreement constitutes the entire agreement of the parties regarding the matters addressed and supersedes all prior oral and written agreements. This Agreement may not be modified or amended except by written agreement executed by all parties.

10. <u>Governing Law and Venue</u>. This Agreement is governed by and construed in accordance with the laws of the State of Arizona without regard to any conflict-of-laws rule or principle that might refer the governance or construction of this Agreement to the laws of another jurisdiction. Any legal proceeding brought in connection with disputes relating to or arising out of this Agreement will be filed and heard in Pima County, Arizona, and each party waives any objection that might arise to such venue and any right it may have to claim that such venue is inconvenient.

11. <u>Cancellation for Conflict of Interest</u>. This Agreement is subject to cancellation for conflict of interest pursuant to A.R.S. § 38-511, the pertinent provisions of which are incorporated into this Agreement by reference.

Purpose:

The purpose of this policy is to establish guidelines governing the conveyance, to financial contributors, of legally enforceable naming rights to County-owned or operated facilities and programs.

Background:

While public facilities are dedicated to all citizens, the County sometimes chooses to name a facility, facility element, or program in a manner that honors a person for their financial generosity or nonmonetary public contributions, with no related binding agreement with that person. This policy does not impact or in any way limit the Board's discretion to do that.

Sometimes, however, a financial contributor may, as a condition of making a substantial grant or donation, require the County to make a legally binding naming commitment. In addition, the County may choose to create programs that encourage the making of smaller financial contributions in exchange for installation in County facilities of engraved bricks or tiles, or installation of recognition plaques on fixtures such as benches, kennels, or pathway segments. This policy is intended to govern grants of enforceable naming rights to private parties.

Definitions:

As used in this Policy:

- A "Facility" is a Pima County-owned or operated building, structure, thoroughfare, or park in its entirety.
- A "Facility Element" is a component of, or a sub-area within or associated with, a Facility. Facility Elements include, but are not limited to, exterior landscaped areas, open areas, and plazas; interior meeting rooms, atriums, and offices; benches, equipment, furnishings, and other fixtures; and segments of roads, paths, walkways, and other thoroughfares.
- A "Program" is any public service, operation, event, or series of events that is provided, performed, or sponsored by the County, and any individual unit or units within an ongoing service or operation or a series of events.
- A "Donor" is a person who donates money, goods, or services to the County in exchange for Naming Rights.
- "Naming Rights" means a binding agreement by the County to (1) designate and refer to a Facility, Facility Element, or Program, by a name or title designated by a Donor, such as in announcements and written materials, and/or (2) mount or imbed on a Facility or Facility Element, a sign, plaque, tile, brick, or other item containing a name or other text designated by a Donor.

Policy:

The County Administrator is authorized to develop programs for the granting of Naming Rights in order to recognize Donors who provide financial assistance—whether in the form of a one-time grant or a commitment to make continuing periodic contributions—with the construction or installation of a County Facility or Facility Element, or for the implementation or maintenance of a County Program. This may include multiyear Naming Rights for entire Facilities and Programs, as well as smaller-scale Naming Rights for Facility Elements. The programs must be consistent with the following general guidelines:

- 1. The scope of the Naming Right—in terms of the scale and prominence of the Facility, Facility Element or Program with respect to which the Naming Right is granted—and its duration, should correspond to the scale of the financial assistance provided by the Donor. No Naming Right may last for more than 20 years.
- 2. A Naming Right that applies to an entire Facility or Program, or that is for more than 5 years (unless terminable at will by the County), must be competitively marketed to multiple potential donors before being conveyed, and any such conveyance must be approved in advance by the Board of Supervisors.
- 3. The specific nature, scope, and duration of the Naming Right must be memorialized in a written agreement with the Donor, the form of which has been reviewed and approved by the Civil Division of the County Attorney's Office.
- 4. As part of each program, procedures must be implemented to administer and track Naming Rights that have been granted.
- 5. The proposed conveyance of Naming Rights involving any improvement funded in whole or in part with the proceeds of tax-exempt bonds, which bonds are still outstanding in whole or in part, must be reviewed and approved by the Director of the Finance and Risk Management Department, to ensure there is no impact on the tax-exempt status of the bonds.
- 6. To the extent possible, the agreement with the Donor should preserve the County's flexibility to make changes to Facilities, Facility Elements, and Programs in order to serve the public interest.
- 7. The name or other text chosen by the Donor must be (1) either (a) the true name of one or more persons or of an organization other than an organization whose principle function is to advocate for or against a person running for elected office or influence political or policy decisions, or (b) other text that is not obscene, misleading, defamatory, or disruptive; and (2) sufficiently brief so as to fit within the space available. The County has sole authority to determine and assure compliance with this item and to select the text's font size, style, and color.

- 8. No Naming Right may include the conveyance of any proprietary or ownership interest in any County property or any special, preferential, or exclusive right to utilize any Facility or Facility Element (except for the purpose of the displaying the Donor's name).
- 9. No Naming Right may be granted in a manner that creates a conflict of interest or the appearance of a conflict of interest.

Implementation:

The County Administrator shall develop and distribute administrative procedures governing the conveyance of Naming Rights consistent with this Policy.
