Agenda Item #22 Amendment #1 Request

BOS 3-21 Agenda Item #19 proposes to hire two non-exempt Recorder employees, total salary just under \$100,000/yr total. After-Action Report to the Election Integrity Committee (EIC) by the Recorder part of the 01-20-23 approved Minutes also indicates increasing intermittent staffing during elections. The Elections Director for the 1-20-23 Approved minutes for the EIC After Action Report indicates plans to purchase more Express Vote machines, renting additional Electronic Poll Books, and planning to order more Electronic Poll books. All of this is NOT cost savings. When the big push was on to convert Pima County to the new Vote Center Model including E-Poll books, the positive benefit was cost savings. Pima County continues to spend our tax dollars on a program that does not work. When do cost savings happen?? Another promotion of the Wote Model comment was "no equipment is connected to the Internet". What happened?? Where are the answers to all our election issues? At the EIC 3-17-23 meeting, after some discussion by the EIC Advisory Board, it was questionable if there even exists an established Pima County Election Protocol to follow for Pima County elections.
