CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

- 1.1. <u>Background</u>. On May 5, 2020, County and Contractor entered into the above referenced agreement to allow operation and maintenance of Centro Del Sur Community Center and Boxing Gym.
- 1.2. <u>Purpose</u>. Contractor is using the Premises solely for the purpose of operating, administering and coordinating the training of youth and adult-based amateur and professional boxing programs, martial arts, and weight and physical training. The purpose of this amendment is to extend the contract for one additional year.
- 2. Term. The County is exercising the third extension option to renew the contract for one additional year commencing on May 5, 2023 and terminating on May 4, 2024. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.
- 3. Forced Labor of Ethnic Uyghurs. Pursuant to A.R.S. § 35-394, if Contractor engages in forprofit activity and has 10 or more employees, Contractor certifies it is not currently using, and agrees for the duration of this Contract to not use (1) the forced labor of ethnic Uyghurs in the People's Republic of China; (2) any goods or services produced by the forced labor of ethnic Uyghurs in the People's Republic of China; and (3) any contractors, subcontractors or suppliers that use the forced labor or any goods or services produced by the forced labor of ethnic Uyghurs in the People's Republic of China. If Contractor becomes aware during the term of the Contract that the Company is not in compliance with A.R.S. § 35-394, Contractor must notify the County within five business days and provide a written certification to County regarding compliance within one hundred eighty days.
