The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

1.1. Background. On August 25, 2020, County and Contractor entered into the above referenced agreement to provide legal services to Pima County in *Taylor v. Pima County, et al.*, Federal District Court Case No. 4:15-CV-00152-TUC-RM.

1.2. Purpose. County requires continuing services and requires additional funds to perform those services, commencing March 5, 2024.

**2. Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in Section 5.2, is increased by \$250,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$845,000.00.
