**Election Board Worker Appointments** 

## \*Introduction/Background:

The Elections Department recruits board workers (poll workers) for each of the 122 Vote Center locations being used on Election Day. Each election board consists of equitable representation from Pima County's two major political parties.

## \*Discussion:

A.R.S. §16-531(A) requires the Board of Supervisors to appoint election board workers for each vote center not less than twenty days before an election.

## \*Conclusion:

By approving the appointment of election boards recruited by the Elections Department for the March 19, 2024 Presidential Preference Election, the Board of Supervisors and the Elections Department will be in compliance with A.R.S. §16-531.

## \*Recommendation:

The Elections Department recommends approval of election board workers for March 19, 2024 as proposed.

## \*Fiscal Impact:

Board workers are paid a stipend, as approved by the Board of Supervisors, utilizing funds from the Elections Department's annual budget.
