Dear Board of Supervisors and County Administrator Jan Leshner,

I urge you to approve the final plan for the Mosaic tomorrow. This is an important economic driver for our community as well as opportunity to expand youth sports in Pima County.

I am a girl hockey mom! I started my daughter in roller hockey because at the time, the availability of ice in Tucson was difficult for the Junior Roadrunners to schedule. Practice times were provided at the last minute and often late at night. However, after two years of roller she wanted to switch to ice and we did with the caveat we were not driving to Phoenix to be on a team there. She played for the Junior Roadrunners for 3 seasons and was one of two girls who played on the varsity team for two years. At this time, they are the only two girls who have played at that level in Tucson.

Last year, she decided she wanted to play more competitively, and she went to the Kachinas in Phoenix. They are the only AAA girls program and are part of the Coyotes organization. All practices are in Phoenix and we drive up at least 3-days a week for her to practice and this does not include any games. I share this story because it is the same one shared by many ice parents in Tucson who are able to afford both the financial and time commitment to drive to Phoenix to give their kids this opportunity. There are many other players who are just as competitive of players but can't play at a higher level because of the commitment. Having dedicated ice in Tucson will be a game changer. While it seems there are not many hockey players in Tucson, there are and I believe this sport will explode.

As for my daughter, she has committed to the University of Arizona Women's hockey team and will be the first "home town girl" to play for the team!

Beyond the ice, the other athletic opportunities with the Field House will drive increased tourism for the region as tournaments start to pop up for the different sports bringing families from all over to stay and compete.

Youth athletics are game changer for kids. I firmly believe kids who are involved in sport will stay out of trouble. Sports provide guidance, discipline and self-motivation for kids. Skills we can't teach.

In addition, this project will provide opportunities for low-income youth to learn and play sports they otherwise might not have the opportunity to play. There are also the jobs that will follow, providing economic opportunities for the surrounding neighborhoods.

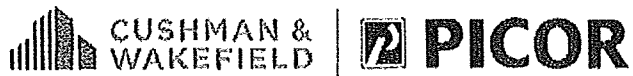
While my story is the same as many other hockey parents, I hope it provides a solid foundation for why this project is so important to Pima County.

To whom it may concern:

I'm writing to you today in support of the Mosaic Quarter Ice hockey complex. I moved to Tucson in 2020 from the state of Connecticut for a job opportunity. I've met a lot of people out here who have moved from cold weather states and have the same love for hockey as myself. As the restrictions during the pandemic eased up, I signed up for the Tucson Adult Hockey League and have been playing with them ever since. Over the last few years, I've found that the vast majority of the players I've met in the league have at least one child enrolled in youth hockey.

Growing up playing hockey on the east coast on multiple travel teams, I'm all too familiar with the dedication and commitment required from season to season. Everyone I know here with kids playing in a youth league have to travel to the Phoenix area at least 3 times a week for practices and games. Even the U of A athletes have to travel in the off season for ice time. Bringing a rink back to Tucson, especially after the housing boom the last few years in which many cold state residents moved out here, would benefit the city and the community as well as the college, collectively.

Between the "beer league" players, the college and high school and youth leagues games and practices, a new facility would invigorate an already over abundant hockey community here in Tucson. Having a state of the art facility would also attract outside organizations to bring their teams and tournaments here. I recall fond memories of my youth teams traveling to Newport, Vermont annually for a tournament at their new arena. Over a decade later, my youngest brother and his organization travelled to the same rink for their regional tournaments. The Mosaic Quarter project would bring those long term opportunities to the area.

The love for the game has grown exponentially since the last arena shut down in 2007. The hockey community is rooting for this project's success and supports it every step of the way. With a local rink, hundreds of kids would have an opportunity to grow their love for the game, cementing it's foundation as a long standing establishment in the community for generations to come. The job opportunities to support it, in addition to the TCC savings with no longer having to maintain an ice surface, would also aid the city. With a new rink, the Roadrunners, U of A, adult and youth leagues would all have a new place to call home.

We are a passionate community and truly, deeply hope that this project moves forward as soon as possible. We are eager to see ground breaking and construction begin so that Tucson, not Phoenix, can be the home of hockey here in Arizona.

I hope this email finds you well. My name is Daniel Lusher, and I am the Head Coach of the Tucson High School Roadrunners ice hockey program. I am going on 7 years of experience leading the High School varsity level team, and 13 years of total experience coaching different age levels in the Tucson ice hockey community as a whole. My hope is to give you, the reader, a quick look into the world of ice hockey in Tucson, specifically at the amateur level. And by that, I hope to impress upon you how much of a boon having the Mosaic Quarter in Tucson would be for the community.

Every Tuesday and Thursday at 8:45pm-9:45pm, we have close to 40 high school students and families show up at the Tucson Convention Center for *irregularly* scheduled practices. There are weeks where kids attempting to play in a competitive league must go without ice for a variety of reasons out of our control, such as the Gem Show, the rodeo, even one year a Janet Jackson concert kicked us out. But when we do have ice, the kids always show up. On the weekends, we usually travel to Phoenix for a majority of the 20 regular season games we play (only 4 out of 20 were held in Tucson this year). I see 40 kids come to the rink, but every one shows up for reasons entirely their own. However, they all do share a common trait – they love the game of ice hockey.

That love of hockey is contagious. It can take over a town in a few short years. Here in Tucson, that has already been seen especially with the arrival of the AHL Roadrunners. The first High School season for our organization was in 2018-2019, and we boasted a total high school athlete roster of 16 players. 6 years later, and despite the hardships of COVID where we had no ice in Tucson for just under a full year, we have nearly 250% growth in high school-aged athletes alone. That's not counting our under-14 ages that are a different section of our organization (which boasts over 200 total players).

A famous quote from Field of Dreams comes to mind: "If you build it, he will come." However for Tucson, there's one small difference. ***We're already here.*** Ice hockey might be Tucson's best kept secret, but the hockey community at large is ready for it not to be a secret anymore. From the youngest players just learning to skate in the Coyote's-supported Little Howler's program, through the 40 young adults that I coach, and up through the AHL, Tucson is ready for the growth and consistency that would be available should the Mosaic Quarter be approved. I'm very hopeful that you will make the right choice and approve the go-ahead for building the Mosaic Quarter in its entirety in this final vote.

There's always a seat in the stands during our games for proud hockey supporters, and we'd love to see you next season. Amateur hockey in Tucson is passionate, thrilling, community-driven, and ready to be shared. Just remember to bring a blanket.

To Whom It May Concern:

It has been brought to my attention that the Mosaic Quarter project will be going through another round of votes to gain approval to move forward. I am a coach and a father of an ice hockey player for the Junior Roadrunners. Over the past four plus years of participating in the Junior Roadrunners program I have seen the ebb and flow of its success. There are many factors that go into the success of that program, but one of the biggest factors is limited ice time and opportunities. Not only would the Mosaic Quarter provide additional opportunities for the ice hockey program, but it would also provide so much more for the community at large.

Since January 19th, we have had one practice, and our next skate will be March 10th. That is nearly two months with only one session on the ice. This makes it very challenging to continuity for growth. Our players are forced to find opportunities in the Phoenix market or may find other sports to participate in. Both of these can certainly lead to a bleeding effect. Once they get used to driving up to Phoenix, they may realize the quality of the programs in that market and may chose not to return the following season. If they find a different sport to be easier to participate in and is more consistent, we may never see those kids play ice hockey again. Having more ice time would allow for additional training in the form of camps and increased competition. I have seen our program bleed a lot of players to the Phoenix market for a multitude of reasons and other kids just quit the program altogether, but I strongly believe the major factor is the limited opportunities. While the TCC is a tremendous venue to play at, it, as you are already aware, prioritizes so many things over the Junior Roadrunners and justifiably so. Because of this, our kids are automatically at a disadvantage.

The loss of players to the Phoenix market has impacted the Junior Roadrunners program in that many times it is the more talented and obviously committed players and families that do so. Because of this we have difficulty putting together enough players to even create a full travel team which leads to a lack of competition for the players that do remain which stunts their growth as players and individuals. If we can't create competition for these players, they will almost certainly find other avenues like driving to Phoenix or finding other sports. While the leadership of the Junior Roadrunners has done a great job to build a competitive house league, it required taking players from different age groups to do so, but from my understanding they were only able to do that for the 12U program. The 10U and 14U have suffered from the lack of participation. New families and players that are currently registered in 10U or 14U may not want to return next year for because of this lack of participation - it continues to be a snake eating its own tail.

In addition to losing players, we are also losing talent each year. Wanting talented players remain in this market is not a selfish act, rather it raises the level of play for all players that participate. It challenges others to work harder, provides more opportunities to create additional teams, and builds confidence to newcomers that we have a legitimate program worth sticking around for. There is only so much we can do as coaches and program directors to build a program when you are limited by your opportunities to find ice time.

I remember when we first joined the Tucson Roadrunners. We drove to the TCC not really knowing what to expect, but when we rode down the escalator and saw kids changing in the open concourse I was stunned. As I mentioned before, the TCC is an amazing venue to play at; I don't think the kids even realize how lucky they are that they get to play and practice on the same ice as a high-level professional hockey team. I would have loved to have that opportunity as a child. But for all the good that creates, it doesn't make up for the fact they don't have locker rooms to change in. I'm not going to go into the boys and girls needing their privacy aspect of it, but I could certainly see that some families may be concerned about this especially as the kids get older and more mature. The kids and families that are participating don't seem to mind too much, but those are the ones that are there. What about the ones that aren't. Additionally, it just doesn't present

well when teams actually do travel to play in Tucson, which is obviously a little rare considering we can't even get enough ice times for our own games. This leads me to my next point.

I have spent some time traveling to El Paso, TX and in the New Mexico market to play a few travel games with those programs out there when the timing works out. During those times I have found that these other teams also have limited opportunities to compete and grow. They have to travel long distances, especially El Paso, to find teams to compete against. They would certainly travel to Tucson to play hockey, but because we do not have a venue to play at, we cannot host these teams or tournaments. As I stated before, we lose much of our talent to Phoenix the quality of our competition does not rise to the level of competition in Phoenix. Therefore, we are unable to compete against their house teams and are forced to build our own or travel all the way to New Mexico, as far as Los Alamos, or El Paso. These opportunities to travel to New Mexico and El Paso are great experiences for our kids, but I am confident that having our own venue would allow us to host teams from all markets, including Phoenix, and cultivate a high class, top-level program.

I have seen the plans for the Mosaic Quarter and every team in the southwest would love to play in such venue. It would allow Tucson to be an ice hockey destination as well as a place for other sports to begin such as figure skating and others that have no footprint right now. Lastly, and probably most importantly, for the people wanting to build the Mosaic Quarter, the developers of businesses in the surrounding area, and for the community at large it would generate revenue and tourism allowing the communities on the south side of Tucson to flourish. Building this state-of-the-art ice center will allow kids and families to fall in love with ice sports and develop youth programs that will propel them in the future all while-creating tourism and businesses to provide jobs and wealth for our community. Tucson deserves to have something this great.

Dear Pima County Board of Supervisors,

I am writing to implore you to support the final approval of the Mosaic Quarter Iceplex project. I have been involved with the Wildcat Youth Hockey Association / Tucson Junior Roadrunners for 7 years. I have watched this organization provide a place for kids to develop a love for the game of hockey. The kids learn skills that build confidence, athleticism, and competitiveness in an environment that is focused on meeting kids where they are so they can develop at their own pace and be put in a position where every player can find some success every day if they put in the effort. This is all done solely with volunteerism from the coaches to administration, and at a fraction of the cost of most hockey programs in the state. It is truly a community hockey program.

We can't offer anywhere near the amount of ice time that programs in metro Phoenix can offer their players. Our travel teams spend the same amount of time on the TCC ice as our house programs, in some seasons sharing ice with the house programs. Our house level players have the skill to compete against many out-of-town programs, but due to our ice limitations they just don't get the game action that they need to be ready for those experiences. Despite our limitations, the Junior Roadrunners program won a State Championship in the Arizona Youth Hockey League last year and has placed several players in elite travel and junior hockey programs both in and out of state. This is an indication of a program doing things the right way.

The organization has had steady growth year over year, bringing in far more kids each year than those who decide to leave for other sports or other programs, with the lone exception being the pandemic period where we had no access to the TCC for over a year. While the pandemic season set us back in terms of enrollment, it delayed us from reaching a point where the available ice for rent at the TCC was going to begin to limit the quality of our program in terms of the amount of time available on the ice for each child. Our last two sessions of Learn to Play have had the highest retention of any of the previous sessions, and we are approaching the conflict of participation and quality again. The Mosaic Quarter

Iceplex project is critical for us to continue to grow and develop Tucson's hockey community and build strong fan bases for both the Tucson Roadrunners and the University of Arizona's Wildcat Hockey program.

Last month, I was able to band together a group of girls from ages 9-14 for a trip to Santa Fe, New Mexico to play against a girls' team from that area. Every year, we bring several girls into the program and it is normal for boys and girls to play in an integrated fashion in the younger age groups. Generally speaking, we have to do that at all ages in our current environment. This is the first season I have had enough girls close enough in age to put together an all-girls team, albeit for a few isolated events with a broadened age group. As you can tell from the smiles in the photo, this was the sort of trip these girls will always remember.



The Mosaic Quarter project will ensure I can provide similar opportunities for all our players in the future, and that they will be ready for those opportunities when they come.

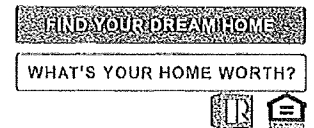
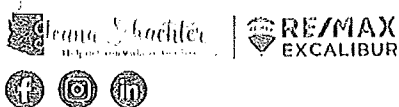

Adult detention center: It is absolutely plain that the ADC is a necessity and that it is unsafe and filthy.
