BOARD OF SUPERVISORS' MEETING MINUTES

The Pima County Board of Supervisors met in regular session at their regular meeting place in the Pima County Administration Building (Hearing Room), 130 West Congress Street, Tucson, Arizona, at 9:00 a.m. on Tuesday, February 4, 2014. Upon roll call, those present and absent were as follows:

1. **PERSONAL POINT OF PRIVILEGE**

Chair Bronson remembered John Hill, Pima County Employee, and expressed condolences to his family.

Supervisor Elías remembered John Carlson Sr. and his contributions to the community.

2. INVOCATION

The invocation was offered by Pastor David Hook, Christ Lutheran Vail.

3. PLEDGE OF ALLEGIANCE

All present joined in the Pledge of Allegiance.

4. PAUSE 4 PAWS

The Pima County Animal Care Center showcased an animal available for adoption.

5. CALL TO THE PUBLIC (for Executive Session items only)

Pete Sabin, Assistant Business Manager for IBEW, Local 570, spoke on the number of unemployed workers, the number of jobs that would be created, the country's need for copper and the benefits the Rosemont Mine would bring to the community.

Mark Sutton, President of Meridian Engineering Company, spoke in support of the Rosemont Mine and asked the Board to consider unemployed individuals and the business community in their decisions.

6. **CONVENE TO EXECUTIVE SESSION**

On consideration, it was moved by Supervisor Valadez, seconded by Supervisor Elías and unanimously carried by a 5-0 vote, that the Board convene to Executive Session at 10:23 a.m.

7. **RECONVENE**

The meeting reconvened at 12:24 p.m. All members were present.

EXECUTIVE SESSION

8. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Target Corporation v . Pima County, Arizona Tax Court Case No. TX2012-000555, Tax Parcel No. 141-22-0290 for tax year 2013.

Chris Straub, Chief Civil Deputy County Attorney, stated these cases involved a proposed settlement regarding a challenge for tax years 2013 and 2014 on the valuation of real property and improvements known as the Target.com Retail Distribution Warehouse. The proposed settlements would reduce the full cash value of the parcels, the legal class would remain the same and the approximate tax decrease for tax year 2013 would be \$37,936.91 and for tax year 2014 would be \$52,420.00. The total tax refund/correction for the two years would be \$90,356.91. He explained as part of the settlement the parties had agreed to bear their own costs for attorney and litigation expenses. The Pima County Attorney's Office and County Assessor recommended the proposed settlement for the two tax years.

It was moved by Supervisor Elías, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to accept the recommendation.

9. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Target Corporation v . Pima County, Arizona Tax Court Case No. TX2013-000244, Tax Parcel No. 141-22-0290 for tax year 2014.

(<u>Clerk's Note</u>: See Minute Item No. 8 for discussion/action on this matter.)

10. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding potential County objections to the Final Environmental Impact Statement and Record of Decision for the Rosemont Copper Project.

Chris Straub, Chief Civil Deputy County Attorney, stated the item concerned the County's potential response to the Final Environmental Impact Statement and the Draft Record of Decision regarding the proposed Rosemont Copper Mine. The Pima County Attorney's Office and County Administrator sought authority to proceed with objections as discussed in executive session.

It was moved by Supervisor Elías, seconded by Supervisor Carroll and carried by a 4-1 vote, Supervisor Miller voted "Nay," to support the recommendations.

11. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Star Valley Specific Plan, Star Valley Master Block Plat, Star Valley individual block plats, development issues and transportation improvements related to Star Valley and Star Valley Village Plats and related development issues and transportation improvements.

Chris Straub, Chief Civil Deputy County Attorney, stated the item related to incomplete developer transportation improvements in the Star Valley residential development located near the intersection of Valencia Road and Wade Road. He explained this matter was informational only and no action was required by the Board.

12. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Valencia Kolb Properties, L.L.C., et al. v. Pima County, United States District Court Case No. 13-CV-01319, alignment of the Valencia-Kolb intersection and related Regional Transportation Authority Risk Mitigation Analysis.

Chris Straub, Chief Civil Deputy County Attorney, stated this item related to property owner's lawsuit against Pima County alleging that the County was legally obligated to reconstruct the intersection of Valencia and Kolb Roads on a southern alignment. The Pima County Attorney's Office sought authority to defend the case as discussed in executive session.

It was moved by Supervisor Elías, seconded by Supervisor Carroll and unanimously carried by a 5-0 vote, to accept the recommendation.

BOARD OF SUPERVISORS

13. Legislative District 2

Appointment to fill the vacancy in the Arizona House of Representatives, Legislative District 2.

Chair Bronson stated the Democratic Party Elected Precinct Committeepersons had submitted the following names as nominees to be considered for filling the vacancy in the District 2 Arizona House of Representatives: Demion Clinco, Miguel Cuevas and Annabelle Nunez.

It was moved by Supervisor Valadez and seconded by Supervisor Carroll, to approve the appointment of Demion Clinco to fill the vacancy for Arizona Legislative District 2. Upon roll call, the motion carried by a 3-2 vote, Chair Bronson and Supervisor Elías voted "Nay."

Both Chair Bronson and Supervisor Elías congratulated Mr. Clinco on his

appointment, and stated that they had hoped to see another woman appointed to the seat.

14. **Pima County Fair Commission**

Pima County Fair Commission and Southwestern Fair Commission, Inc. appointments, membership, Bylaws and establishing Resolutions. Discussion/Amendment/Vote. (District 1)

Supervisor Miller stated the item had been placed on the agenda to clarify the rules governing appointments to the Pima County Fair Commission as the documents regarding the Pima County Fair Commission and the Southwestern Fair Commission, Inc., contained conflicting information.

It was moved by Supervisor Miller and seconded by Supervisor Valadez, to affirm and clarify that the rules of Resolution No. 1974-124, paragraph 4, be adhered to when appointing members to this commission and that the past convention of each Board member having individual District nominations with the approval of the Board majority continue. No vote was taken at this time.

Chris Straub, Chief Civil Deputy County Attorney, stated that as a matter of law, the original governing document, Resolution No. 1974-124, would prevail.

Bob Patrick, former Management Assistant to the County Manager, provided historical background on the formation on the Pima County Fair Commission and the purpose of the non-profit Southwestern Fair Commission, Inc.

Jon Baker, Executive Director, Southwestern Fair Commission, addressed the Board regarding his background and the recommendations for the operation of the Commission which included the membership being comprised of individuals with certain professional expertise.

Chuck Huckelberry, County Administrator, reported on the shift from an at large appointment structure to a District appointment structure.

Supervisor Valadez proposed an amendment to the motion that the Southwestern Fair Commission Bylaws be changed to read "removal for cause," to match the resolution language. Supervisor Miller accepted the amendment to the original motion.

Upon roll call, the motion unanimously carried by a 5-0 vote.

Chair Bronson asked if the Board wished to change the appointment process for the Commission.

Supervisor Carroll requested the Pima County Fair Commission make a recommendation for future consideration by the Board regarding the appointment process.

It was moved by Supervisor Elías, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to adopt the Resolution.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to close the public hearing, approve the permit and forward the recommendation to the Arizona Department of Liquor Licenses and Control.

Staff requests an allocation from the Board of Supervisors ' Contingency Fund in the amount of \$12,500.00 for the University of Arizona Mobile Health Program.

Supervisor Miller objected to the use of the Board of Supervisors' Contingency Fund which was to be used for emergencies and was almost depleted. She added that the County should stop funding the University of Arizona.

It was moved by Supervisor Miller to deny the item. The motion died for lack of a second.

It was then moved by Supervisor Valadez, seconded by Supervisor Carroll and carried by a 4-1 vote, Supervisor Miller voted "Nay," to approve the item.

Authority to enter into contract negotiations under Solicitation No. 104346 with the Joint Venture of Anaergia, Inc. (Headquarters: Burlington, Ontario, CAN) and Grannus Biogas, L.L.C. (Headquarters: Tucson, AZ), for the Pima County Biogas Sales and Utilization Project. The awardee will construct, own and operate a biogas cleaning and conditioning facility adjacent to the Tres Rios Water Reclamation Facility. RWRD will provide digester gas that the developer will clean and condition to natural gas pipeline guality (biomethane) and sell on the open market. The County will be paid a commission on gross sales and lease payments for the land provided for the facility. This contract will be for a period of fifteen years with an option of one five year extension. In the event contract terms cannot be negotiated with the recommended firm, request authorization to terminate negotiations with that firm and proceed to negotiations successively with the next highest ranked firms in the following order: Biofuels Energy, L.L.C. (Headquarters: Encinitas, CA), then Ameresco, Inc. (Headquarters: Framingham, MA), until the final list is exhausted. Funding Administering Department: Source: N/A. Regional Wastewater Reclamation.

Supervisor Elías stated this was a public health issue and that the County was not meeting our responsibility to the public by privatizing this project which involved hazardous materials. He also added that the sale of biogas for electricity would reap a tremendous profit.

It was moved by Supervisor Elías to deny the item. The motion died for lack of a second.

It was then moved by Supervisor Valadez, seconded by Supervisor Miller and carried by a 4-1 vote, Supervisor Elías voted "Nay," to approve the item.
