WHEREAS, Tucson Wildlife Center was created in 1998 to rescue, rehabilitate and release injured, sick or orphaned wild animals throughout southern Arizona; and

WHEREAS, in the beginning, the Tucson Wildlife Center was treating approximately 300 animals per year; today, they are treating more than 1,000 animals each year; and

WHEREAS, Tucson Wildlife Center operates with a small staff and over 70 volunteers, including a volunteer board of directors and volunteer veterinarians; and

WHEREAS, Tucson Wildlife Center promotes habitat protection and co-existence through education; and

WHEREAS, Tucson Wildlife Center is supported by the local community and donors; and

WHEREAS, from the bequest of Sam Goldman, the Tucson Wildlife Center was able to build the first state-of-the-art wildlife hospital in Arizona; and

WHEREAS, on October 20, 2012, the Tucson Wildlife Center celebrated the ground-breaking for the Sam Goldman Wildlife Hospital; and

WHEREAS, the Sam Goldman Wildlife Hospital features cutting-edge technology that is one-of-a-kind in southern Arizona; and

WHEREAS, in addition to animal care, the Sam Goldman Wildlife Hospital has a unique education room designed to engage coming generations and increase local awareness; and

WHEREAS, with the new Sam Goldman Wildlife Hospital, the Tucson Wildlife Center is now able to provide more efficient care to more animals;
