The Pima County Animal Care Center showcased an animal available for adoption.

5. CALL TO THE PUBLIC (for Executive Session items only)

The Chair inquired whether anyone wished to address the Board on any item listed under Executive Session. No one appeared.

6. **CONVENE TO EXECUTIVE SESSION**

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to convene to Executive Session at 9:08 a.m.

7. **RECONVENE**

The meeting reconvened at 9:21 a.m. All members were present.

EXECUTIVE SESSION

8. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Casas Adobes Baptist Church v. Pima County, Arizona Tax Court Case No. TX2012-000078, Tax Parcel No. 101-01-004E for tax year 2013.

Chris Straub, Chief Civil Deputy County Attorney, stated this concerned a proposed settlement of the case regarding Plaintiff's challenge to the valuation of a free standing building located at 2175 W. Ina Road. The subject property was owned by Casas Adobes Baptist Church and was currently managed under a long-term lease as a retail/pharmacy store by Walgreen's Corporation. The proposed settlement would reduce the full cash value of the subject parcel from its current assessed value for tax year 2013. The legal classification and assessment ratio would remain the same. The resulting total tax decrease for tax year 2013 would be approximately \$20,555.00. These values would statutorily roll over to tax year 2014. The two year total tax savings would be approximately \$43,170.93. As part of the settlement, both sides have agreed to bear their own costs for attorney's fees and litigation expenses. The Pima County Assessor and the Pima County Attorney's Office recommended the settlement.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to accept the recommendation.

9. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding Tucson AZ (Jensen-Horowitz/Dickey), L.L.C. v. Pima County, Arizona Tax Court Case No. TX2012-000082, Tax Parcel No. 133-37-017F for tax year 2013.

Chris Straub, Chief Civil Deputy County Attorney, stated this concerned a proposed settlement of the case regarding Plaintiff's challenge to the valuation of real property and improvements located at 10315 E. Broadway Blvd. The subject property was currently managed under a long-term lease as a retail/pharmacy store by Walgreen's Corporation. The proposed settlement would reduce the full cash value of the subject property from its current assessed value for tax year 2013, which would statutorily roll to tax year 2014. The legal classification and assessment ratio would remain the same. The resulting total tax decrease for tax year 2013 would be approximately \$10,542.30. The two year total tax decrease would be approximately \$21,370.00. As part of the settlement, both sides have agreed to bear their own costs for attorney's fees and litigation expenses. The Pima County Assessor and the Pima County Attorney's Office recommended the settlement.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to accept the recommendation.

10. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding a request by DeConcini, McDonald, Yetwin and Lacy that Pima County waive a conflict of interest to allow the firm to represent Sunnyside Unified School District in a matter pertaining to real property taxes assessed on property owned by the District in the vicinity of Gallego Elementary School.

Chris Straub, Chief Civil Deputy County Attorney, stated this concerned a request by the Law Firm of DeConcini, McDonald, Yetwin and Lacy, that Pima County waive a conflict of interest to allow the firm to represent the Sunnyside Unified School District in a matter pertaining to real property taxes assessed on property owned or allegedly owned by the District in the vicinity of Gallego Elementary School. He stated waivers of conflict of interest are matters solely within the discretion of the Board.

It was moved by Supervisor Elías, seconded by Supervisor Valadez and unanimously carried by a 5-0 vote, to waive the conflict of interest.
