## ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

The Pima County Sheriff's Department requests permission to transfer ownership and title of a 2003 Ford Excursion VIN: 1FMNU41L63ED70754 to the Southern Arizona Rescue Association (S.A.R.A.), a non-profit entity, for \$10.00. The vehicle in question has accrued over 125,000 miles and is being dead-lined by Fleet Services. The Department purchased this vehicle with non-general fund sources (RICO). No Pima County funds were used in the original purchase.

S.A.R.A. has proven to be an invaluable resource and the organization's volunteers have supplemented the Pima County Sheriff's Department Search and Rescue mission for years. The Ford Excursion is off-road capable and has adequate passenger and cargo/towing capacity to meet the needs of Search and Rescue operations affecting the citizens of Pima County. The transfer of vehicle ownership and title to S.A.R.A. for \$10.00 when dead-line is pending is consistent with past practice and may alleviate liability from Pima County.
