**GRANT AGREEMENT AMENDMENT**

WHEREAS, the COUNTY, through the Community Development and Neighborhood Conservation Department has received CDBG funds from the U.S. Department of Housing and Urban Development to provide for CDBG projects in low and moderate income county communities; and

WHEREAS, UCHC Pediatric Dental Program is an appropriate use of CDBG funds; and

WHEREAS, on June 5, 2012, Pima County (COUNTY) and United Community Health Center, Inc. (SUBGRANTEE) entered into the above-referenced grant agreement to purchase clinical equipment for the new Pediatric Clinic in Continental, AZ.; and

WHEREAS, Contract expired before UCHC Pediatric Dental Program could be completed and funds are not fully expended; and

WHEREAS, COUNTY has reviewed SUBGRANTEE'S performance and finds it acceptable; and

WHEREAS, COUNTY AND SUBGRANTEE agree to extend the contract term in order to complete the UCHC Pediatric Dental Program and provide affordable dental care to low-to-moderate income persons in the Continental/Sahuarita/Green Valley communities,

NOW, THEREFORE, the Parties agree as follows:

**A. ARTICLE I – TERM AND EXTENSION/RENEWAL CHANGES**, Paragraph A is amended to **change** the termination date:

All other provisions of this contract, not specifically changed by this amendment, shall remain in effect and be binding upon the parties.


This amendment shall be effective upon execution by the Chairman, Board of Supervisors, provided that it has been previously executed by the SUBGRANTEE.
