#### **GRANT AGREEMENT AMENDMENT**

WHEREAS, the COUNTY, through the Community Development and Neighborhood Conservation Department has received CDBG funds from the U.S. Department of Housing and Urban Development to provide for CDBG projects in low and moderate income county communities; and

WHEREAS, Micro Loan Program is an appropriate use of CDBG funds; and

WHEREAS, on November 13, 2012, Pima County (COUNTY) and Catholic Community Services dba Pio Decimo Center. (SUBGRANTEE) entered into the above-referenced grant agreement to provide business loans in Pima County for small businesses that have difficulty obtaining commercial loans from commercial lenders; and

WHEREAS, Contract will expired before the Micro Loan Program could be completed and funds are not fully expended; and

WHEREAS, COUNTY has reviewed SUGRANTEE'S performance and finds it acceptable; and

WHEREAS, COUNTY AND SUBGRANTEE agree to extend the contract term in order to complete the Micro Loan Program and provide business loans to small businesses,

NOW, THEREFORE, the Parties agree as follows:

A. ARTICLE I - TERM AND EXTENSION/RENEWAL CHANGES, Paragraph A is amended to change the termination date:

From: September 30, 2013

To: September 30, 2014
