NSP1 SUBRECIPIENT AGREEMENT AMENDMENT

WHEREAS, Pima County ("County") sought and received federal funding under Title III of Division B of the Housing and Economic Recovery Act of 2008 (Public Law 110-289) (HERA); and

WHEREAS, on March 19, 2009, the U.S. Department of Housing and Urban Development (HUD) executed the Funding Approval and Grant Agreement for Neighborhood Stabilization Program (NSP) Funds, NSP Grant No. B-08-UN-04-0502, awarding County \$3,086,867.00; and

WHEREAS, on April 8, 2009, County executed the NSP Grant Agreement as County Contract No. 02-70-U-141849-0109 accepting NSP funds; and

WHEREAS, County finds it prudent and in the best interest of county residents to control the distribution and use of program income generated by NSP1 projects to further the goals of Neighborhood Stabilization in Pima County.

NOW, THEREFORE, the parties agree as follows:

- I. Article V Finance, Paragraph A is deleted in its entirety and replaced with the following:
 - A. Consideration to City for this Agreement is:
 - 1. The NSP1 houses; and
 - 2. Management, maintenance, replacement and operating costs not-to-exceed \$50,000.00 during the first eighteen months of the Agreement term (lease-up reserves).
- II. Article VI- Program Income, Paragraph A is deleted in its entirety and replaced as follows:

- **A. Program Income.** All program income shall be returned to County within twenty (20) business days from the end of each quarter in which the program income was received by City. If requested by City, County at its discretion may approve program income for any eligible use as set forth in NSP1 and CDBG rules.
- III. Article VIII-Reporting, Paragraph B, the introductory paragraph is deleted and replaced as follows:
 - B. No later than the 20th business day of the month following each quarter, City shall provide a quarterly performance and expenditure report for the previous quarter which must include all information required by HUD for performance under NSP1. Each report shall include information about the rental operations and program income generated, including but not limited to:

The effective date of this Amendment shall be upon execution by all parties herein. All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.
