ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:
ORDINANCE NO. 2014, An ordinance of the Pima County Board of Supervisors, establishing Prima Facie reasonable speed limits for motor vehicles on Hardy Road in Pima County, Arizona. Staff recommends APPROVAL . (District <u>1</u>)
The reason for this ordinance is to reduce the speed limit on Hardy Road from La Canada Drive to Calle Loma Linda (Town of Oro Valley limits) from 45 mph to 40 mph.
Based on a 2013 traffic study, it is recommended that the speed limit on Hardy Road from La Canada Drive to Calle Loma Linda be reduced from 45 mph to 40 mph. This reduction in the speed limit will provide a travel speed consistency along this segment of Hardy Road due to operational and geometric characteristics, projected increased traffic volumes, and traffic congestion during peak hours and to provide continuity to adjacent/intersecting roadway segments. The speed limits on the remaining segments of Hardy Road will not change.



ORDINANCE NO. 2014-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING PRIMA FACIE REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON HARDY ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Hardy Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit for motor vehicles on Hardy Road shall be established as follows:

SPEED LIMIT	<u>FROM</u>	<u>TO</u>
a) 35 mph	1,158 feet west of Holly Brook Avenue	122 feet east of Bottlebrush Lane
b) 35 mph	Camino de La Tierra	Shannon Road
c) 40 mph	La Canada Drive	Calle Loma Linda (Town of Oro Valley limits)

SECTION 2. Ordinance 2009-020 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
