ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2014 - ____, An ordinance of the Pima County Board of Supervisors, repealing an Ordinance establishing a non-abutting school crosswalk on Kain Avenue in Pima County, Arizona. Staff recommends **APPROVAL**. (District 3)

The reason for this ordinance is to authorize abandonment of the existing non-abutting school crosswalk on Kain Avenue at Diamond Street.

The Flowing Wells School District is no longer utilizing and providing crossing guards at the non-abutting school crosswalk on Kain Avenue on the north side of Diamond Street. Staff reviewed the location for other crossing pedestrians and found that the crossing is not being utilized by school children or other pedestrians. With the concurrence of the Flowing Wells School District, this ordinance will repeal Ordinance 1980-228 for a non-abutting school crosswalk at this location and void the existing crosswalk agreement between Pima County and the Flowing Wells School District.

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REPEALING AN ORDINANCE
ESTABLISHING A NON-ABUTTING CROSSWALK ON KAIN
AVENUE IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-797, as amended, to establish non-abutting school crosswalks, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, passed ordinance 1980-228 on October 21, 1980, establishing a non-abutting school crosswalk on Kain Avenue on the north side of the intersection of Kain Avenue with Diamond Street for the students of Laguna Primary School, and

WHEREAS, the Superintendent of the Flowing Wells School District has advised the Board of Supervisors that the non-abutting school crosswalk is no longer needed and has been abandoned by the Flowing Wells School District and Laguna School,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Ordinance 1980-228 establishing a non-abutting school crosswalk on Kain Avenue on the north side of the intersection of Kain Avenue with Diamond Street is hereby repealed.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflict.

SECTION 3. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


