ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:
ORDINANCE NO. 2014, An ordinance of the Pima County Board of Supervisors, establishing Prima Facie reasonable speed limits for motor vehicles on Overton Road in Pima County, Arizona. Staff recommends APPROVAL . (District <u>1</u>)
The reason for this ordinance is to reduce the speed limit on Overton Road between Thornydale Road and La Canada Drive from 45 mph to 40 mph.
Based on a 2013 crash assessment and follow-up speed limit review, it is recommended that the speed limit on Overton Road be reduced to 40 mph between Thornydale Road and La Canada Drive. This reduction in the speed limit will provide a travel speed consistency along these segments of Overton Road due to operational and geometric characteristics, new recreational facilities, crash history, projected increased traffic volumes, and traffic congestion during peak hours. This will also provide continuity between adjacent/intersecting roadway segments.



ORDINANCE NO. 2014-

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING PRIMA FACIE REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON OVERTON ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Overton Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit for motor vehicles on Overton Road shall be established as follows:

<u>SPEED LIMIT</u> <u>FROM</u> <u>TO</u>

40 mph Thornydale Road La Canada Road

SECTION 2. Ordinance 1992-99, Section 1, Part 291 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
