ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2014 - ____, An ordinance of the Pima County Board of Supervisors, establishing Prima Facie reasonable speed limits for motor vehicles on Shannon Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1)

The reason for this ordinance is to reduce the speed limit on portions of Shannon Road between Orange Grove and Lambert Lane (Town of Oro Valley limits) from 45 mph to 40 mph.

Based on a 2013 crash assessment and follow-up speed limit review, it is recommended that the speed limit on Shannon Road be reduced to 40 mph from Orange Grove Road to 775 feet south of Ina Road and from Magee Road to Lambert Lane. This reduction in the speed limit will provide a travel speed consistency along these segments of Shannon Road due to operational and geometric characteristics, existing school facilities, crash history, projected increased traffic volumes, and traffic congestion during peak hours. The speed limit on the remaining segments of Shannon Road have not changed.

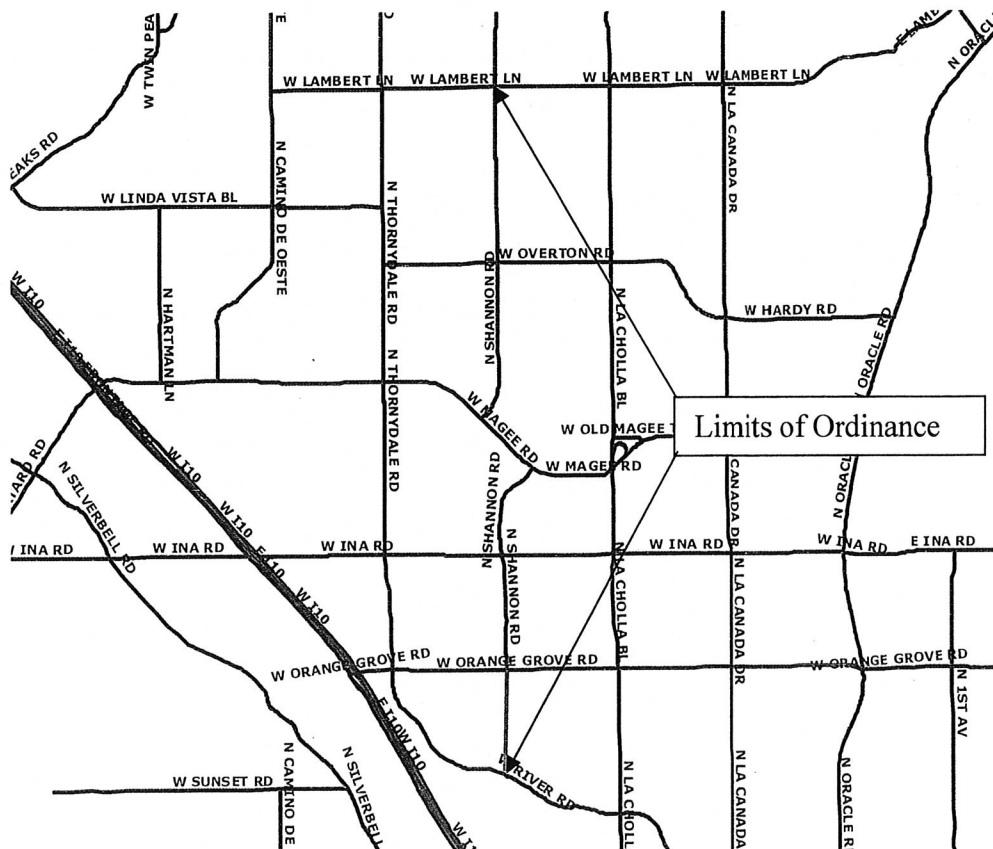

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING PRIMA FACIE
REASONABLE SPEED LIMITS FOR MOTOR VEHICLES
ON SHANNON ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Shannon Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit for motor vehicles on Shannon Road shall be established as follows:

<u>SPEED LIMIT</u>	<u>FROM</u>	<u>TO</u>
a) 35 mph	260 feet north of River Road	Orange Grove Road
b) 40 mph	Orange Grove Road	775 feet south of Ina Road
c) 35 mph	775 feet south of Ina Road	Magee Road
d) 40 mph	Magee Road	Lambert Lane (Town of Oro Valley limits)

SECTION 2. Ordinance 2003-092 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.




