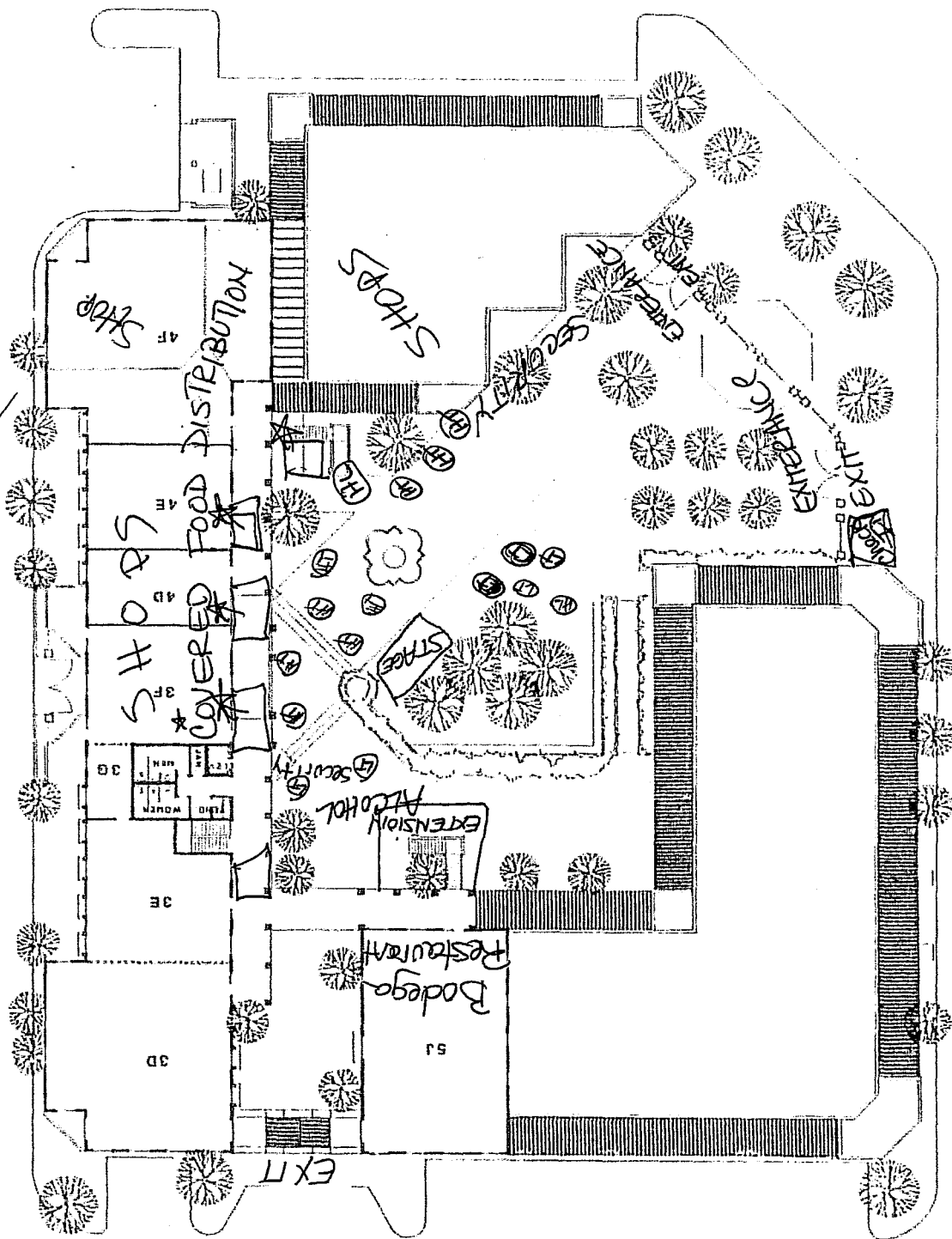

We are requesting a permit under the Application For Extension of Premises/Patio Permit. On the evening of May 03, 2014 Pima County Medical Society Alliance (PCMSA) will hold *Wine Country in the Desert* at **St. Philips Plaza** to benefit **Mobile Meals of Tucson**. The event will be held in the evening from **6-9 p.m.** The PCMSA is a 501C3 (**PCMSA TAX ID# 86-0307702**) and is a group of physician's spouses/significant others who have been raising money for over 50 years to support agencies within Pima County to better the lives of the men, women and children in need. **We will have security at each gate checking for the private attendees.**

All proceeds from the event will go to Mobile Meals of Tucson, which delivers meals to disabled and/or elderly homebound adults who are unable to shop or make meals for themselves. In 2012, Mobile Meals delivered more than 100,000 meals to 785 clients. Of the Mobile Meals delivered, 78% of the clients are over the age of 60 and 63% are female. Mobile Meals of Tucson deliver to 33 routes daily by 418 volunteers. This makes it possible for the 785 adults to sleep in their own beds and have a place to call their own.
