## ITEM SUMMARY, JUSTIFICATION \&/or SPECIAL CONSIDERATIONS:

Stewart Title \& Trust of Tucson, an Arizona corporation, as trustee under trust number 2549 ("Donor") owns Pima County Tax Parcels Number 140-36-005A (the "Property"). Donor wishes to donate a Two Slope Easements, Temporary Construction Easement and Right of Way for the Valencia Road: Alvernon to Wilmot Improvement Project. The Property will be conveyed to County free and clear of any monetary liens and encumbrances and upon completion of construction activities the Temporary Construction Easement shall terminate. County will pay all closing costs and escrow fees associated with the foregoing conveyance, including the premium for a Standard Owner's Title Insurance Policy for a coverage amount of $\$ 20,000.00$. All closing costs, including the premium for a Standard Owner's Title Insurance Policy are not expected to exceed $\$ 1,000$.

STAFF RECOMMENDATION(S): Staff recommends that the Board of Supervisors approve and execute the Agreement to Donate Real Property and to authorize the expenditure of an amount of NOT TO EXCEED $\$ 1,000$ to pay for closing costs and escrow fees, including the premium for a Standard Owner's Title Insurance Policy.

This Agreement is made and entered into this $23^{\text {rd }}$ day of December, 2013, by and between Stewart Title \& Trust of Tucson, an Arizona corporation, as trustee under trust number 2549, ("Donor") and PIMA COUNTY, a political subdivision of the State of Arizona, ("Donee"), (collectively, the "Parties").

## WITNESSETH:

WHEREAS, Donor is the owner of real property identified as Pima County Tax Parcel No.
$\qquad$ , $\qquad$ and $\qquad$ 140-36-005A, and Donor desires to donate to Donee two slope easements, right of way and a temporary construction easement as described in Exhibits A, B, C and D attached hereto and made a part hereof,

WHEREAS, Donee is in need of the two slope easements, right of way and the temporary construction easement for the Valencia Road: Alvernon to Wilmot Road Improvement Project.

NOW THEREFORE, in consideration of the foregoing recitals and the mutual covenants set forth herein,

## THE PARTIES AGREE

1. Pursuant to paragraphs 7 and 8 below, Donor will donate to Donee, the two slope easements, right of way and a temporary construction easement described in Exhibit(s) A, B, C and D attached hereto, for the Valencia Road: Alvernon to Wilmot Road Improvement Project.
2. Donor has been fully informed of the right to have an appraisal performed to establish the value of the easements, right of way and temporary construction easement and to receive just compensation for such easements, right of way and temporary construction easement based upon an appraisal, and Donor agrees that the decision to donate said easements, right of way and temporary construction easement was made without any undue influence or coercive action of any nature. Donee hereby waives the right to an appraisal and to just compensation for the easements, right of way and temporary construction easement to be conveyed to Donee hereunder.
3. Donor will execute all necessary documents conveying the easements, right of way and temporary construction easement described herein to Donee upon presentation of said documents to Donor by Donee's agents or representatives at Closing.
4. Risk of Loss for Damage to Improvements. Donor shall bear the risk of loss or damage to any improvements located on the easements, right of way and temporary construction easement prior to Closing. After Closing, the risk of loss or damage to any
improvements located on the easements, right of way and temporary construction easement shall rest with Donee.
5. No Salvage. Donor shall not salvage or remove any fixtures, improvements, or vegetation from the easements, right of way and temporary construction easement, but this shall not prohibit Donor from removing personal property prior to Closing. In addition, prior to Closing, the easements, right of way and temporary construction easement shall not be materially degraded by Donor or otherwise materially changed in any material aspect by Donor.
6. All provisions herein shall be binding upon the heirs, successors and assigns of the Parties.
7. Pursuant to that certain Exchange Agreement between Donor and Donee dated 7/30/2012 (the "Exchange Agreement"), the Parties exchanged certain parcels of real property, Donor conveyed to Donee additional land and easements, and Donee agreed to install a signalized traffic intersection at the realigned Littletown Road and Valencia Road as part of the RTA funded Valencia Road Widening Project. In addition, Donee and Donor are holding an unrecorded deed to Donor for a portion of Littletown Road which will be recorded upon relocation of Littletown Road as further provided in the Exchange Agreement.
8. Following the execution of the Exchange Agreement, further traffic study analysis conducted by Donor concluded that an additional left turn lane is required for the realigned Littletown Road and Valencia Road intersection. In order to accomplish the additional left turn lane, the right-of-way for the intersection as currently designed must be increased. The real property interests that Donor is conveying to Donee pursuant to this Agreement constitute the additional right-of-way required for the additional intersection widening and are described in paragraph 1 . To accomplish the necessary design alteration for the additional left turn lane, Donor agrees to pay the reasonable and necessary costs and expenses charged by Psomas Engineering for the design alterations to accommodate the new left turn lane, but in no event shall Donor be required to pay, in the aggregate, more than Forty Five Thousand Dollars $(\$ 45,000.00)$ for the design alterations (the "Fee Cap"). Donee agrees to and shall pay all other costs associated with constructing the redesigned Littletown Road and Valencia Road intersection, including any additional design and engineering costs in excess of the Fee Cap.
9. County shall pay all closing costs, including the title insurance premium, escrow fees, and recording fees. Those costs shall not exceed $\$ 1,000.00$
