ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2014 - \_\_\_\_, An ordinance of the Pima County Board of Supervisors, regulating traffic at the intersection of Bayou Drive and Treece Way in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1)

The reason for this ordinance is to authorize enforcement of a stop condition for Bayou Drive at Treece Way.

A routine signing review found a stop sign installed for northbound Bayou Drive at Treece Way with no existing Traffic Engineering documentation regarding the signs installation. A follow-up traffic study determined that the stop sign is warranted with northbound traffic on Bayou Drive stopping for traffic on Treece Way. The stop sign has been left in place for safety and this ordinance will authorize enforcement of the stop condition.

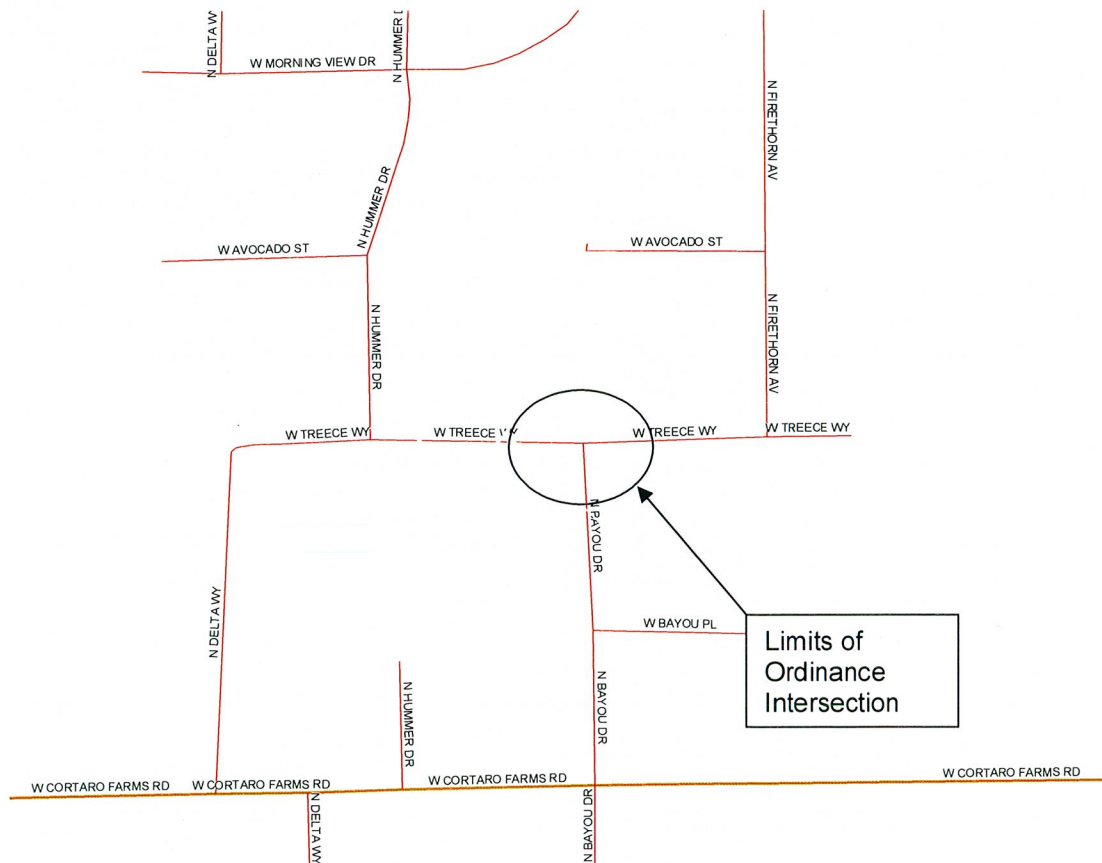

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF  
SUPERVISORS REGULATING TRAFFIC AT THE  
INTERSECTION OF BAYOU DRIVE AND TREECE  
WAY IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Bayou Drive and Treece Way as a stop intersection,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The intersection of Bayou Drive and Treece Way be designated a stop intersection with traffic on Bayou Drive stopping for traffic on Treece Way.

**SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


