10. Ebola virus disease (EVD) investigation guidelines and an Ebola Response Plan

Arizona Department of Health Services (ADHS) has collaborated with the County Public Health Departments to develop Ebola virus disease (EVD) investigation guidelines and an Ebola Response Plan as a framework for State and County Public Health epidemiologic response. Routine calls with County Health Departments ensure coordination and information sharing between State and County Public Health partners.

10.1. Requirements

The Pima County Health Department shall:


- 10.1.1. Follow any person, with a risk of EVD from one of the Ebola-affected countries through active monitoring (if low risk) or direct active monitoring (if some or high risk);
- 10.1.2. Implement a combination of direct active monitoring, travel restrictions, and/or isolation and quarantine, in case of a high risk traveler;
- 10.1.3. Conduct daily follow up with each high or low risk person;
- 10.1.4. Arrange an evaluation at the individual's home or at a pre-identified designated medical facility in case a person develops a fever or symptoms consistent with EVD;
- 10.1.5. Conduct an initial phone screening for low, but not zero risk individuals or an in-person visit for all some or high risk individuals;
- 10.1.6. Provide communication instructions for the duration of monitoring, including directions to contact the County Public Health Department immediately if symptoms develop;
- 10.1.7. Conduct subsequent follow-up of some and high risk travelers by virtual direct observation or in-home direct observation depending on the scenarios;
- 10.1.8. Coordinate safe transport to the designated medical facility in case a monitored individual develops symptoms;
- 10.1.9. Prevent exposure to healthcare workers and other patients at the facility by giving the designated medical facility advanced notice about arrival of suspect case; and
- 10.1.10. Notify Centers for Disease Control (CDC) if a monitored individual is being considered for EVD testing.

10.2. Tasks

The Pima County Health Department shall:

- 10.2.1. Submit Plans to ensure daily contact with people under active monitoring, along with specific methods of contact (if applicable);
- 10.2.2. Provide a description of methods used to have daily face-to-face contact with people under direct active monitoring (can be via electronic methods such as Skype or Face Time);
- 10.2.3. Ensure that the County Health Department is in compliance with daily and weekly monitoring reports and provide further details regarding lost follow-up with all, some, or high risk individuals
- 10.2.4. Provide a description of what actions the County Health Department will take with regard to those who have not been contacted within twenty-four (24) hours (i.e. how will those lost in follow-up be handled?);
- 10.2.5. Provide a description of what actions the County Health Department will take if contacts refuse to comply with monitoring measures prescribed by jurisdiction.
- 10.2.6. Ensure that the monitoring process includes a discussion with people under monitoring, in regards to the plan for care if the person exhibits symptoms consistent with EVD, including identification in advance, the evaluation hospital, possible EVD testing and clinical management for up to ninety-six (96) hours; and
- 10.2.7. Ensure that the County Health Department and State Health Department has developed emergency medical services (EMS) plans to assure safe transport of a person under investigation to the nearest appointed hospital, in accordance with the State's Ebola treatment plan and that EMS has been trained on personal protective equipment (PPE) use.
