## HIV CARE AND SERVICES

Effective April 1, 2015, it is mutually agreed that the Intergovernmental Agreement referenced is amended as follows:

1. Pursuant to, Terms and Conditions, Provision Six (6), Contract Changes, Item 6.1, Amendments, Purchase Orders and Change Orders, the Agreement is hereby extended through March 31, 2018.
2. The Price Sheet of the original Agreement is hereby replaced with the revised Price Sheet of this Amendment (3). The total of the revised Price Sheet is increased from \$56,666.00 to \$77,871.00 due to the following line item changes:
  - 2.1 Core Medical Personnel & ERE increased by \$19,776.00, from \$50,011.00 to \$69,787.00, due to an increase of 1.30 in their personnel.
  - 2.2 Core Medical Services Delivered remains at the same amount, \$1,005.00.
  - 2.3 Administration Services Delivered increased by \$1,429.00, from \$5,650.00 to \$7,079.00, due to increased early intervention services.

ALL OTHER PROVISIONS OF THIS AGREEMENT REMAIN UNCHANGED.
