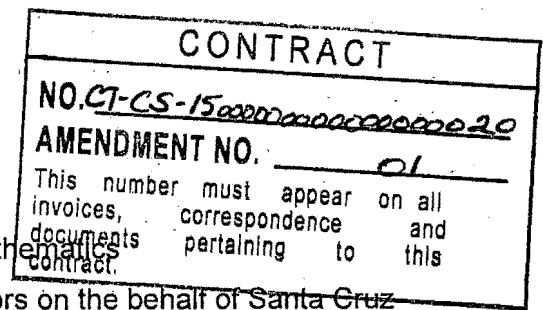

Pima County a body politic and corporate of the State of Arizona ("County") and Santa Cruz County ("Contractor") have entered into the above referenced agreement to provide workforce development services for youth and adults in Southern Arizona.

AMENDMENT

WHEREAS, the Pima County Board of Supervisors finds that continuing to provide workforce development services for youth and adults in Southern Arizona is in the best interests of the County; and

WHEREAS, County has reviewed Contractor's performance and finds it satisfactory; and

WHEREAS, the parties agree to extend the Contract for the provision of services through June 30, 2016.

NOW, THEREFORE, COUNTY and CONTRACTOR agree to amend the Contract as follows:

1. **ARTICLE I – TERM AND EXTENSIONS**, Paragraph A, is amended follows:

A. The termination date is changed:

FROM: June 30, 2015

TO: June 30, 2016

B. The number of available extensions is changed:

FROM: four (4) 12-month periods or any portion thereof

TO: three (3) 12-month periods or any portion thereof

All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.






