Requested Board Meeting Date: July 7, 2015

**Title:** Repealing Ordinance of Non-Abutting Crosswalk on Sweetwater Drive at Willemite Drive.

### **Introduction/Background:**

The Tucson Unified School District (TUSD) has confirmed the school crosswalk on Sweetwater Drive west of Willemite Drive for Robins Elementary School is no longer in use by school-aged pedestrians and has approved that the school crosswalk be removed.

### **Discussion:**

Pima County Traffic Engineering Division conducted a school crosswalk study and confirmed that no school-aged pedestrians during beginning and ending hours of school sessions were using the school crosswalk. Further, staff did not see any regular pedestrians using said crosswalk during study times either.

### **Conclusion:**

As a result of no use, TUSD has approved that the County may remove the school crosswalk which will release TUSD of any contractual obligations to said crosswalk.

### **Recommendation:**

Pima County Traffic Engineering Division recommends the crosswalk on Sweetwater Drive west of Willemite Drive for Robbins Elementary School be removed along with any pertaining traffic control devices to said crosswalk.

**ORDINANCE NO. 2015-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REPEALING AN ORDINANCE FOR A NON-ABUTTING SCHOOL CROSSWALK ON SWEETWATER DRIVE AND WILLEMITE DRIVE IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-797B, as amended, to establish a non-abutting school crosswalk, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, passed ordinance 2001-19 on February 06, 2001, establishing a non-abutting school crosswalk, and

**WHEREAS**, the non-abutting school crosswalk is no longer in full use by school-aged pedestrians as confirmed by the Pima County Department Transportation, Traffic Engineering Division, and as approved for removal by the Tucson Unified School District (TUSD) Department of School Safety.

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** Ordinance 2001-19 establishing a non-abutting school crosswalk on Sweetwater Drive on the west side of the intersection with Willemite Drive is hereby repealed.

**SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflict.

**SECTION 3.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


