THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Kinney Road from Gates Pass Road to Naomi Road shall be temporarily closed to public traffic on Sunday, July 12, 2015 from 4:50 A.M. to 7:00 A.M.
