


Appendix B: PCHD Organizational Chart

Response to request for additional information regarding RFP No.AHDS15-00004913, Health Start Program

1. Method of Approach (Section 2.5)

Section 2.5.5 Describe how the outreach is conducted via social media;

Social media will be used in a variety of ways as part of the overall outreach program. As part of the outreach strategies for Public Health Nursing (PHN) services, Pima County Health Department's (PCHD) website:

http://webcms.pima.gov/cms/One.aspx?pageId=182757 has information on various maternal child programs offered through the Health Department, including Health Start. There is a link to a referral form on the website so that providers, community agency staff or potential clients may be referred for Health Start, Nurse-Family Partnership or other appropriate services.

Through a Maternal Infant Early Childhood Home Visiting (MIECHV) grant, PCHD and the United Way of Southern Arizona have developed a centralized referral system. Providers may refer clients either through the PCHD website or through the Pima County Parenting Coalition website, call in a referral to a warm line or fax in a referral to PCHD or United Way. A protocol has been drafted and the home visiting coordinator at PCHD and/or at United Way reviews the referral and determines what programs best meet the needs of the family.

Pima County Health Department has a Facebook page and information about the Health Start program will be posted on Facebook. The PCHD communication team frequently sends out "tweets" on various health related topics such as flu or pertussis vaccinations. The communications team will be asked to tweet messages about the Health Start program. The communications team is able to monitor "hits" on the Facebook and the number of Twitter followers.

Section 2.5.7 (1) The response did not specify the required four (4) hours or more hours of consultation from a Registered Nurse and a Licensed Social Worker or Licensed Counselor per month, and

(2) Clarify if the Registered Nurse is in-kind service as it not listed on the budget sheet.

There will be a minimum of four (4) hours of consultation from Gabriela Arriaga, RN per month. Up to 48 hours/contract year will be billed for. Any RN consultation time over the minimum of four (4) hours per month will be provided as in-kind services by PCHD. The Licensed Social Worker or Licensed Counselor will provide a minimum of four (4) hours per month of consultation with Health Start staff. All hours of consultation provided by the social worker or counselor will be billed for.

2. Cost (Section 2.8)

Provide best and final pricing for the following: Section 2.8.6 Rate per Person for Alcohol, Tobacco, Other Drugs Screening Visits:

The price quoted in the original RFP of \$130 per Alcohol, Tobacco, Other Drugs Screening visits was based on the current contracted amount paid for the Enhanced Alcohol Screening visits (\$130). We would be willing to reduce reimbursement for this screening visit to \$120 per visit and would increase the number of screening visits to 134 for the contract year. This would leave the total amount billed for these visits at \$16,120.

Section 2.8.7 Rate per Person for Brief Intervention Visits;

The price quoted in the original RFP of \$150 per visit was based on the current contracted amount paid for the Enhanced Brief Intervention Visit. Part of the calculations for this rate was to compensate for additional required forms such as Form H for which we are not able to bill. Since there has been a reduction in the number of uncompensated forms that are required related to a positive alcohol, tobacco or other drugs screening result, we would be willing to decrease compensation to \$130 per visit. The projected number of visits would be 17.3 visits, leaving the total billable amount of \$2,250.

Section 2.8.12 Rate per person for Pregnancy Test Visits (Optional Services), and also explain why the projected number is so low per year.

The price quoted in the original RFP of \$100 per visit was based on the current contracted amount paid for the Pregnancy Test Visits. The projected number of visits was low, at 15 visits, based on the number of negative pregnancy tests completed between July — December, 2014. The Health Start CHWs are co-located in offices with our Family Planning clinics and many times women coming into the offices are seen by Family Planning clinic staff. Family Planning also bills their funding source for pregnancy testing so there is some competition for the clients. We would be willing to reduce our compensated rate to \$80 per Pregnancy Test Visits and increase the number of pregnancy tests to 19 visits, keeping the total dollar amount at \$1,500.

The total budget amount requested would remain at \$215,890.
