Project Title/Description:

Third Amendment to Lease

Purpose:

Velv, LLC, an Arizona Limited Liability Company dba Arizona Shuttle, is leasing County property to operate an airport shuttle drop-off site. The property is located on the south side of Ina Road, between Interstate 10 and the Santa Cruz River, 5051 W. Ina Rd., Marana, Arizona, in Section 1, Township 13 South, Range 12 East.

Procurement Method:

County staff seeks Board of Supervisors approval of a Third Amendment to Lease.

Program Goals/Predicted Outcomes:

Staff recommends that the Board of Supervisors approve the Third Amendment to Lease extending the lease term for one year.

Public Benefit:

The County will allow Arizona Shuttle to continue to operate its airport shuttle drop off site on the County property, and the County will receive fair market value rental income.

Metrics Available to Measure Performance:

The rent rate is supported by an appraisal. The rent increased to \$2,000/month as of April 25, 2014.

Retroactive:

The lease amendment is retroactive to April 25, 2015. Arizona Shuttle has continued to use the property and to pay market rent at \$2,000/month. The amendment was prepared by Real Property, sent to tenant for execution, but was not obtained prior to April 25, 2015.

 - 1.2. Tenant: Velv a Limited Liability Company, dba Arizona Shuttle
 - 1.3. Premises: see attached Exhibit "A"
 - 1.4. <u>Lease</u>: The lease for the Leased Premises naming Tenant as tenant, dated April 25, 2007, and all amendments thereto
 - 1.5. Effective Date: April 25, 2015
- 2. **MODIFICATION OF LEASE**. Landlord and Tenant hereby agree to modify the terms of the Lease as follows:
 - 2.1. The term of the Lease Agreement referred to above is hereby extended to April 25, 2016, pursuant to Section 3 of the Lease Agreement.

- 3. **REMAINING LEASE TERMS UNCHANGED**. Except as modified as provided in this Amendment, all of the terms and conditions of the Lease shall remain in full force and effect.
- 4. **EFFECTIVE DATE**. This Amendment shall be effective as of the Effective Date.

THENCE North 89°55'43" West, a distance of 185.00 feet;




