Project Title/Description:

Port of Tucson Expansion - Sub Grant Agreement for Tiger Grant

Purpose:

Pima County and The Port of Tucson jointly applied for a 2013 TIGER discretionary grant, and were awarded the grant in October 2013. The sub-grant contract must also be in place for the grant to pass through the County to the Port for the actual construction of the improvements. This Amendment will extend the sub-grant contract for one year to allow for the completion of construction.

Procurement Method:

Program Goals/Predicted Outcomes:

The objective of the Project is to install rail infrastructure improvements at the Port of Tucson on the Union Pacific Railroad ("UPRR") mainline, within the current right-of-way - specifically, the construction of an extension of the Wilmot siding and the Port of Tucson industrial lead and the installation of powered switches controlled from the Harriman Center at Omaha, Nebraska.

Public Benefit:

These improvements will allow trains to enter the Port of Tucson and fully clear the mainline prior to stopping, thus eliminating impacts to other UPRR traffic and making use of the Port more efficient for intermodal freight operations.

Metrics Available to Measure Performance:

The metrics include the quality of work improvements, completed within budget and in a timely manner.
