Title: Resolution Authorizing Pima County to Condemn for North Rillito Interceptor Project

Introduction/Background:

Pima County plans to construct and maintain certain sewer improvements for the North Rillito Interceptor Project (the "Project") and requires certain interests in real property for the Project.
