Requested Board Meeting Date: October 6, 2015

Title: Craycroft Road Speed Limit

Introduction/Background:

The Pima County Traffic Engineering Division received a citizen request to lower the speed limit on Craycroft Road north of Sunrise Drive. The current speed limit on Craycroft Road from Sunrise Drive to Ventana Heights Place is 40 mph.

Discussion:

The Pima County Traffic Engineering Division conducted a speed limit review along Craycroft Road from Sunrise Drive to Ventana Heights Place as a result of the request. Based on roadway geometrics and alignment, user and operational characteristics and crash history, it is recommended the speed limit be reduced.

Conclusion:

The 40 mph speed limit on Craycroft Road is recommended to be reduced to 35 mph from Sunrise Drive to Ventana Heights Place as a result of the division's speed limit review. Craycroft Road turns into Kolb Road east of Ventana Heights Place and the recommended speed limit provides continuity with the 35 mph speed limit on Kolb Road. The remaining speed limits on Craycroft Road will remain unchanged.

Recommendation:

The Pima County Traffic Engineering Division is recommending previous ordinance 2013-57 be repealed and the 40 mph speed limit be reduced to 35 mph on Craycroft Road from Sunrise Drive to Ventana Heights Place.

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING PRIMA FACIE
REASONABLE SPEED LIMITS FOR MOTOR VEHICLES
ON CRAYCROFT ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Craycroft Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit for motor vehicles on Craycroft Road shall be established as follows:

<u>SPEED LIMIT</u>	<u>FROM</u>	<u>TO</u>
a) 35 mph	180 feet north of Los Reales Road	Littletown Road (City of Tucson limits)
b) 45 mph	Valencia Road	Drexel Road
c) 45 mph	River Road (City of Tucson limits)	Sunrise Drive
d) 35 mph	Sunrise Drive	Ventana Heights Place

SECTION 2. Ordinance 2013-57 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


