Title: Ordinance to Regulate Traffic at Morning Jewel Place and Sunset Surprise Way

Introduction/Background:

The Pima County Traffic Engineering Division received a citizen request for the installation of a stop sign or yield sign at the intersection of Morning Jewel Place and Sunset Surprise Way. The citizen indicated that vehicles traveling on Sunset Surprise Way are speeding and not stopping at Morning Jewel Place.

Discussion:

As a result of the request, a study was conducted at the intersection to determine if regulatory traffic control was warranted.

Conclusion:

The intersection study determined that stop control is warranted for southbound vehicles on Sunset Surprise Way at Morning Jewel Place due to sight distance restrictions.

Recommendation:

Fiscal Impact:

The Pima County Traffic Engineering Division recommends that a stop sign be installed for southbound Sunset Surprise Way at Morning Jewel Place based on the results of the intersection study in order to reduce potential vehicular conflicts.

ORDINANCE NO. 2015-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING TRAFFIC AT THE INTERSECTION OF MORNING JEWEL PLACE AND SUNSET SURPRISE WAY IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Morning Jewel Place and Sunset Surprise Way as a stop intersection,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** The intersection of Morning Jewel Place and Sunset Surprise Way be designated a stop intersection with southbound traffic on Sunset Surprise Way stopping for traffic on Morning Jewel Place.
- **SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
