# Project Title/Description:

Pima County Free Library State Grants-in-Aid 2016/designated amount for the City of Tucson through State Grants-in-Aid appropriations directed at libraries for current fiscal year.

#### Purpose:

This funding will allow the library to support an important community engagement effort called the the White House Connect-ED project. Funds will purchase technology to allow staff to issue cards off site and fund programming that enhances language, reading, and critical thinking skills of for youth -- by presenting their stories about the Library in a theatrical performance that will be featured at the Library's Tent during the Tucson Festival of Books. The effort will create framework for sustainable model of service for beneficial school library partnerships.

#### **Procurement Method:**

## **Program Goals/Predicted Outcomes:**

Increase number of new library cards for customers in outlying areas of the county and elementary school children with barriers to accessing library resources, increase the number of ebook downloads and number of database uses.

## Public Benefit:

PCPL is working with Tucson Unified School District and Literacy Connects to help the most disadvantaged children get library cards and connect families with the electronic resources available to them as a result of getting their card.

#### Metrics Available to Measure Performance:

Metrics will be collected through Library data gathering reports, attendance logs, circulation reports for the Bookmobile, and database usage reports per IP address.
