Project Title/Description:

Pima County Free Library State Grants-in-Aid 2016/designated amount for Pima County through State Grants-in-Aid appropriations directed at public libraries for current fiscal year.

Purpose:

Contract for professional services to deliver a leadership and staff development program for the Pima County Public Library. Twenty applicants currently in managerial positions will be selected to form this cohort. Participants will focus on topics related to building capacity for leadership and organizational effectiveness.

Procurement Method:

Program Goals/Predicted Outcomes:

To nuture core leadership and staff engagement that is connected to organizational wellness, capacity, productivity, profitability, and customer satisfaction.

Public Benefit:

Pima County residents will benefit from succession planning with a focus on building executive skill sets and in supporting strong functioning areas for the Pima County Library, from personnel to enhanced communication, to cultural competence, to facilities and financial capacity.

Metrics Available to Measure Performance:

Metrics will be collected using pre/post program strength-based assessment tests, and progress reports, evaluations on participants learning objectives, and related to completion of assignments to continue to develop the skills learned.


