Title: I-19 & Irvington ADOT (relocation of sewer facilities)

## Introduction/Background:

The Pima County Regional Wastewater Reclamation Department plans to relocate certain sewer improvements for the Arizona Department of Transportation road improvements at I-19 and Irvington.

## **Discussion:**

This Resolution will authorize the County Attorney to acquire property under the County's eminent domain authority where necessary for the relocation of sewer improvements for the ADOT project at I-19 and Irvington.

# **Conclusion:**

Acquisition of property for relocation of sewer facilities will be obtained by condemnation if needed.
