Title: Lavery Lane Parking Ordinance

Introduction/Background:

The Pima County Traffic Engineering Division received a citizen concern and information from the Pima County Sheriff's Department regarding vehicles and semi-trucks parking along Lavery Lane in the vicinity of the driveways accessing the Flamingo Suites and Best Western Inn Suites.

Discussion:

As a result of the citizen concern, staff field reviewed the location and found that vehicles and semi-trucks parking in the vicinity of the commercial and residential driveways and side streets obstruct intersection sight distance for entering and exiting vehicles.

Conclusion:

Parked vehicles along Lavery Lane obstruct intersection sight distance for vehicles entering and exiting the driveways and side streets along the segment on Lavery Lane from Oracle Road to Sparkle Lane. Allocating this segment of Lavery Lane as No Parking will improve the intersection sight distance and provide reasonable safety for ordinary travel.

Recommendation:

The Pima County Traffic Engineering Division recommends that parking on the north and south sides of Lavery Lane from Oracle Road to Sparkle Lane be regulated No Parking Anytime.

ORDINANCE NO. 2016-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON LAVERY LANE IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park on Lavery Lane from Oracle Road to Sparkle Lane,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Parking on both the north and south sides of Lavery Lane from Oracle Road to Sparkle Lane shall be regulated No Parking Anytime.
- **SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.
 - SECTION 5. The various county officers and employees are authorized and directed

to perform all acts necessary or desirable to give effect to this ordinance.
