Title: Temporary Road Closure Resolution

# Introduction/Background:

Kenneth Montaney II has requested the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail for the Colossal Cave Road Race on Sunday, February 28, 2016 from 6:30 A.M. to 2:30 P.M.

#### **Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

# Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail to enhance the safety of the Colossal Cave Road Race Tucson event by reducing potential vehicular conflicts.

Staff recommends approval of this resolution to temporarily close portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail for the Colossal Cave Road Race on February 28, 2016 from 6:30 A.M. to 2:30 P.M.
