- The track was an educational resource.
- It would be detrimental to remove the music, dance, sport and culture from the facility.
- Heirloom Farmer's Market supported keeping the multi-use facility and asked the Board to commit to the community and enhance the historic landmark as a public space.
- Over 90 vendors and small businesses and over 1,200 visitors participated in the Farmer's Market every weekend, but if parking were removed it would also take these customer opportunities from small businesses.
- Youth sports, racing, the Farmer's Market and the Celtic Festival could all coexist at the facility.
- Rillito Park is a unique and beautiful facility.
- Changing the park from a multi-use facility would be a tragedy.
- The racetrack employed people from the community and the university, served as a learning lab for students and was a historical landmark.
- Racing season had a direct impact on businesses in the area.

Dennis Currie appealed to the Board to allow the remainder of the Star Valley development to proceed while the courts decided the outcome of the County's claim concerning Camino Verde.

Geri Ottoboni addressed the Board regarding property taxes and spending.

Richard Hernandez spoke on the upcoming 2016 elections and encouraged public participation at meetings.

Manny Lopez, American Legion Post 59, expressed concern regarding the plans for Presido Park and the effect on the memorials currently in the park, specifically related to relocation, possible damage and adherence to proper protocol, and requested a stay on construction until these issues were addressed.

Raquel Baranow spoke regarding the purchase of tax liens at the New Tucson Subdivision, the blog about Sycamore Vista and the subsequent purchase of those liens by Steven Russo.

Phineas Anderson addressed the Board regarding discrepancies in fees paid for use of Rillito Park.

Art Mendoza, Service Employees International Union, spoke in opposition to creating unclassified positions and removal of employees from the protections of the Merit System.

Supervisor Miller stated TREO has been funded for years and had failed to produce results for the County. She questioned why Pinal County only paid \$50,000.00 for membership in the group, and the expenditure of Pima County monies for economic development across the entire southern region when statute stated it should be within the boundaries of the County.

Supervisor Elías asked for a response regarding the County's authority to provided economic development services through this contract and an explanation for the additional \$210,000.00

Thomas Weaver, Chief Civil Deputy County Attorney, stated he was comfortable with the contract from a legal standpoint.

Chuck Huckelberry, County Administrator, stated all goals in the contract are Pima County centric and that the expenditure of the additional \$210,000.00 would be brought back to the Board for a new or expanding employer that would be export based and create jobs for the community.

Supervisor Miller asked if the County properties that would be used for the economic development would be sold or leased at market value.

Mr. Huckelberry said they would be either sold or leased at the value established for economic development purposes.

Upon roll call, the motion carried by a 4 to 1 vote, Supervisor Miller voted "Nay."

She stated there was never a request for special treatment or free parking only a request for an accommodation.

Supervisor Elías commented that special accommodation requests should be made in accordance with the notice on the Board agenda and that everyone be treated equally.

Chair Bronson asked if there was a procedure in place currently to allow public to pay for parking in the A-Level Parking Garage.

Chuck Huckelberry, County Administrator, explained that the spaces on A-Level were rented or leased on a monthly basis with a couple of spaces reserved for conducting County business. He stated there was no reservation system for A-Level.

Supervisor Miller and Supervisor Elías withdrew their motion. Supervisor Miller then made a motion that Ms. Ottoboni request a parking accommodation from the Clerk of the Board. The motion died for a lack of a second. Chair Bronson added that a motion was not required as there was a current procedure in place.
