Title: Revocation of Restrictions and Covenants Running with the Land

Introduction/Background:

Tucson Acquisition and Development Corporation ("TADC") has requested the CCR's be released by Pima County because the lot does not meet the hazardous cross-slope requirement. The TADC lot is tax parcel 222-38-0825 because the lot does not meet the hazardous cross-slope requirement. The TADC lot is tax parcel 222-38-082E located at 4650 E. Wilds Road, lying within Section 15, Township 11, Range 14 G&SRM, Pima County, Arizona.

Discussion:

The average cross slope of the TADC lot and two lots adjacent to the west were all split at the same time in 1990. There was an error in the survey at this time and the natural area set-aside would not have been required.

Conclusion:

This request has been reviewed by appropriate County staff and they agreed to revoking the restrictions and covenants.

Recommendation:

Staff recommends that the Pima County Board of Directors approve and the Chair execute the Revocation.

Fiscal Impact:

The County received a \$100 processing fee for this application.
