WHEREAS, Schuyler Lininger managed and owned the Lodge on the Desert in Tucson, Arizona for 50 years and is a long standing member of the American Hotel and Lodging Association's prestigious Resort Committee where he has worked diligently to provide outstanding lodging and promote tourism in Pima County; and

WHEREAS, the tourism industry in Pima County contributes over \$2.6 billion dollars in direct spending in our community, employing over 22,000 people; and

WHEREAS, Schuyler Lininger is a graduate of the University of Arizona, and has served on the UA Advisory Boards of the College of Business and School of Theater, Film and TV, as well as National Board of Advisors for the Eller College of Management; and

WHEREAS, Schuyler Lininger's leadership promoting tourism in various associations and organizations in Tucson and Arizona, such as:

WHEREAS, Schuyler Lininger has been the recipient of numerous awards including: Distinguished Alumni Service Award College of Medicine, University of Arizona; Distinguished Citizen Award, University of Arizona Alumni Association; Founder's Award, Tucson Metropolitan Chamber of Commerce in 2002; Honoree for the Pima Council on Aging in 2005; and Arizona Ambassador of Tourism Award from Governor Bruce Babbitt; and

WHEREAS, Schuyler Lininger served on the Tucson City Council (1975 - 1976) and was Past Chairman as a part of his long-term service on the Civil Service Commission; and

WHEREAS, Schuyler Lininger is a founding member, Past President and Board Member of SKAL International Tucson, founded 50 years ago on April 14, 1966 and is the Past President of SKAL International USA and North America Area SKAL Committee;

NOW, THEREFORE, BE IT RESOLVED, that the Pima County Board of Supervisors hereby takes great pleasure in honoring Schuyler Lininger for his dedication and community advocacy efforts in growing tourism in our region;
