Recitals

- A. Pima County ("COUNTY") and Green Valley Assistance Services ("AGENCY") have entered into the above-described contract.
- B. On March 3, 2016 the Pima County Outside Agency ("OA") Advisory Committee passed a motion to recommend the reallocation of \$5,000.00 of OA funding from Green Valley Assistance Services to Arivaca Coordinating Council-Human Resource Group, Inc.
- C. COUNTY has reviewed AGENCY's performance and finds it will not have the capacity to expend said funds in client services.
- D. The Pima County Board of Supervisors has determined that it is in the best interests of COUNTY to reallocate the OA funds from AGENCY to Arivaca Coordinating Council-Human Resources Group, Inc. to provide additional emergency services.
