

**SITE-SPECIFIC SUPPLEMENTAL AGREEMENT #3  
TO MASTER AGREEMENT  
RIGHT-OF-WAY USE LICENSE  
FOR WIRELESS COMMUNICATIONS FACILITIES**

This Site-specific Supplemental Agreement is made by and between Pima County ("Licensor"), a political subdivision of the State of Arizona, and Sprint Spectrum, L.P., a Delaware Limited Partnership ("Licensee"), referred to collectively as the "Parties", pursuant and subject to the Master Agreement Right-of-Way Use License for Wireless Communications Facilities entered into by the parties effective June 7, 2015.

**DESCRIPTION OF WIRELESS COMMUNICATIONS FACILITIES**

Co-Location on TEP power pole located at northwest corner of Soldier Trail and Fort Lowell Road. Three (3) panel antennas (1 per sector, 3 sectors total) on 44'0" pole; Three RRU's at base of pole; one (1) GPS antenna; concrete pad; one (2) equipment cabinets.  
Fiber Optic Line on Premises: one Sprint handhold approximately 27' west of existing equipment; conduit from handholds to Sprint teloc box.

This description shall govern in the case of any discrepancies between the description of facilities above and the information presented in Attachment 1.
