Dear Member of the Board of Supervisors,

May 15, 2016

I heartily support the adoption of the Traffic Safety Ordinance that County Administrator Chuck Huckelberry has placed on the agenda for the May 17th, 2016 meeting. Scores of excuses will be made as to why this is a bad idea. We also know there will be those "advocating" for the economically-challenged that these street medians and the abutting corners of intersections are sanctuaries of upward mobility, but this is, at least, nonsense. I appreciate that personal safety appears as the primary motivation for the aforementioned ordinance; yet, I wish denial of other factors were not employed so as to obfuscate the reality of what is going on.

I'm adamantly opposed to the county {or any other level of government} setting up rehabilitation centers for every indigent individual (and any dogs they may have with them).
