Requested Board Meeting Date: August 2, 2016

Title: Fairy Duster Drive Through Street Ordinance

Introduction/Background:

Pima County Traffic Engineering received a citizen request for stop sign installations at the intersection of Fairy Duster Drive and Arguedas Way due to vehicles speeding through the intersection.

Discussion:

As a result of the citizen request, Pima County Traffic Engineering conducted a study at the intersection to determine if regulatory control was warranted.

Conclusion:

Pima County Traffic Engineering determined that yield signs were warranted for eastbound and westbound Arguedas Way at Fairy Duster Drive based on the study results. The yield signs will also establish right of way at the four-legged intersection.

Recommendation:

Pima County Traffic Engineering recommends a through street ordinance be approved for Fairy Duster Drive from Swan Road to 336 feet north of Arguedas Way. The through street ordinance will facilitate the yield sign installations for eastbound and westbound Arguedas Way at Fairy Duster Drive, and will allow for future stop or yield regulatory traffic control installations along the segment if the need arises.

ORDINANCE NO. 2016- ____

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING FAIRY DUSTER DRIVE
AS A THROUGH STREET IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate through streets and erect stop or yield signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate Fairy Duster Drive as a through street,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Fairy Duster Drive be designated a through street from Swan Road to 336 feet north of Arguedas Way.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


