PIMA COUNTY AMENDMENT #2 to

Environmental Access Agreement

THIS AMENDMENT "Amendment" is entered into between Pima County, a political subdivision of the State of Arizona, ("Grantor"), and the Arizona Department of Environmental Quality, an agency of the State of Arizona, ("Grantee") and shall be effective on the date executed by the Pima County Board of Supervisors.

County and Licensee agree that the Environmental Access Agreement ("License") dated March 5, 2013 and recorded on March 12, 2013 in Sequence 20130710245, and amended on November 10, 2015 and recorded on November 20, 2015 in Sequence 20153240071 in the office of the Pima County, Arizona, Recorder is amended to include the eight additional groundwater monitor well locations IRA-44A&B - IRA-47A&B, as "Proposed Wells," as that term is used in the License, and to replace Exhibit A to the License with attached, revised Exhibit A.

All other provisions of the License, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.


