Requested Board Meeting Date: September 6, 2016

Title: Cancellation of Why Domestic Water Improvement District Election

Introduction/Background:

A.R.S. 16-410 allows that if the number of persons who file nomination petitions plus the number of persons who file write-in affidavits is less than or equal to the number of positions to be filled for a water district election, the Board of Supervisors may cancel the election and appoint the person or persons to fill the position for the term of office for which the candidate was nominated.

Discussion:

The Why Domestic Water Improvement District has two positions on the Board of Directors to be filled at the November 8, 2016 General Election. Two or fewer candidates have filed nomination petitions or write-in affidavits for these positions.

Conclusion:

If the Board cancels the election, the Why Domestic Water Improvement District will not incur the expense of conducting an uncontested election. A candidate who has filed nomination petitions or a write-in affidavit for a position on the Board of Directors will be appointed by the Board of Supervisors and will have the same powers and duties as if elected. If no nomination petitions or write-in affidavits have been filed, the position will be deemed vacant.

Recommendation:

Recommend canceling the uncontested Why Domestic Water Improvement District Election for the November 8, 2016 General Election.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS CANCELING THE ELECTION FOR DISTRICT BOARD MEMBERS OF THE WHY DOMESTIC WATER IMPROVEMENT DISTRICT AND APPOINTING GLENN MCCREADY TO THE BOARD OF DIRECTORS.

WHEREAS, the Why Domestic Water Improvement District ("the District"), pursuant to A.R.S. § 48-1012, is required to hold an election to elect two members to the board of directors for those terms that expire December 31, 2020; and

WHEREAS, the number of candidates who filed nominating petitions pursuant to A.R.S. § 16-311, was less than or equal to the number of positions that are up for election to the District board of directors at the November 8, 2016 General Election; and

WHEREAS, when only one person files a nominating petition for election to a position on the District board of directors, the Pima County Board of Supervisors may, pursuant to A.R.S. § 48-1012(E), cancel the election and appoint the person who filed a nominating petition to fill the position; and

WHEREAS, Glenn McCready is the only individual who filed a nominating petition for election to fill one of the two open positions on the board of directors;

NOW, THEREFORE, upon motion duly made, seconded and carried, be it resolved as follows:

That the November 8, 2016 election for two positions on the Why Domestic Water Improvement District Board of Directors is cancelled and Glenn McCready is appointed to serve on the Why Domestic Water Improvement District Board of Directors for a four-year term beginning on January 1, 2017.
