Project Title/Description:

Agreement for Transfer of Entitlement Funds to the Coolidge Municipal Airport Authority, Coolidge Airport

Purpose:

As the Eric Marcus Municipal Airport (Ajo, Arizona) is classified as a general aviation airport by the Federal Aviation Administration (FAA), it is eligible to apply for Airport Improvement Program funds on a yearly basis for capital projects. Pima County does not have a specific project for these FY 2013 funds for the Eric Marcus Airport. If no action is taken by Pima County, the funds will revert to the FAA's Airport Improvement Program for reallocation at the national level. Pima County can authorize the release of the funds to another airport in the region. Coolidge Municipal Airport has a specific project and can provide the required local funding match in order to receive these funds. The Department recommends that the federal funds be transferred to the Coolidge Municipal Airport Authority, Coolidge, Airzona for local airport improvements.

Procurement Method:

Exempt pursuant to Pima County Code 11.04.020

Program Goals/Predicted Outcomes:

The Board authorize the FAA to reprogram the funds for use by the Coolidge Municipal Airport, and cooperation with the Coolidge Municipal Airport to complete and fund their project.

Pima County will allow the FAA to Transfer the Entitlements to Coolidge Municipal Airport for their project
