Title: Summit Street Parking Restrictions

Introduction/Background:

The reason for this ordinance is to establish No Stopping, Standing, or Parking Anytime on both sides of Summit Street from 260 feet west of Vanessa Lane to 340 feet east of Vanessa Lane.

Discussion:

A plan to install a walkway on the south side of Summit Street as approved by the Pima County Traffic Engineering Division includes the installation of a new school crosswalk approximately 40 feet east of Vanessa Lane. For the safety of school-aged pedestrians, the school crosswalk is subject to parking restrictions to Arizona State and Pima County standards and engineering judgment on both sides of Summit Street in the vicinity of this new school crosswalk. Summit View Elementary and Sunnyside School District acknowledge and approve the revised school crosswalk and no parking zone location.

Conclusion:

With the installation of a new school crosswalk, No Parking anytime is to be implemented on both sides of Summit Street in the area of the school crosswalk for the safety of school-aged pedestrians.

Recommendation:

Pima County Traffic Engineering Division recommends No Stopping, Standing, or Parking Anytime on both sides of Summit Street from 260 feet west of Vanessa Lane to 340 feet east of Vanessa Lane.

ORDINANCE NO. 2016-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON PORTIONS OF SUMMIT STREET IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park on both sides of Summit Street from 260 feet west of Vanessa Lane to 340 feet east of Vanessa Lane,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Parking on both sides of Summit Street from 260 feet west of Vanessa Lane to 340 feet east of Vanessa Lane shall be regulated No Stopping, Standing or Parking Anytime.
- **SECTION 2.** Ordinance No. 1998-92 and any other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.
- **SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
