## INTERGOVERNMENTAL AGREEMENT AMENDMENT

WHEREAS, Pima County ("County") has entered into an Intergovernmental Agreement ("IGA") with the Vail Unified School District ("VUSD"), IGA Number CTN-TR-160\*11, for design and construction of improvements as part of the Colossal Cave Road, Acacia Elementary to Old Vail Middle School, Tucson, Arizona (4RTCCS) Project ("Project"); and

WHEREAS, VUSD has paid to County the \$200,000.00 contribution provided for in the IGA; and

WHEREAS, VUSD desires that County construct additional improvements to Old Vail Road depicted in attached **Exhibit A-1** ("Old Vail Improvements"), which were not contemplated by the IGA; and

WHEREAS, County is willing to construct the Old Vail Improvements, and VUSD is willing to compensate County for 100% of the cost of constructing the Old Vail Improvements (\$42,975.00); and

WHEREAS, an extension of the IGA's termination date is necessary to allow County to complete the Old Vail Improvements, as well as the improvements originally contemplated by the IGA.

NOW, THEREFORE, the IGA is amended as follows:

- 1. Insert the following paragraph at the end of Section 3.1 of the IGA:
  - "The Old Vail Improvements consist of paving 820 Lineal Feet of Old Vail Road to provide a paved access to VUSD properties located along Old Vail Road, as depicted in Exhibit A-1."
- 2. Add \$42,975.00 to VUSD's contribution toward the cost of the Project. VUSD shall pay to County \$42,975.00 in a single lump sum payment due no later than 30 days after the effective date of this Amendment One.
- 3. Modify the capitalized term "Project Plans" in the IGA to include the plans in Exhibit A-1.
- Change Section 2 of the IGA as follows:

From: "This Agreement shall become effective upon execution by the Parties and shall continue in effect until the Project improvements are fully constructed or the Agreement is terminated pursuant to the terms contained herein, but in no event shall this Agreement remain in effect after December 30, 2016, unless extended by written amendment signed by the Parties."

To: "This Agreement shall become effective upon execution by the Parties and shall continue in effect until the Project improvements are fully constructed or the Agreement is terminated pursuant to the

terms contained herein, but in no event shall this Agreement remain in effect after December 28, 2018, unless extended by written amendment signed by the Parties."

Add Exhibit A-1, attached to this Amendment Number 1. All references in the IGA to Exhibit A

5. Add Exhibit A-1, attached to this Amendment Number 1. All references in the IGA to Exhibit A are changed to refer to Exhibit A and Exhibit A-1.

The effective date of this Amendment shall be **December 13, 2016**. All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.

IN WITNESS THEREOF, the County has caused this Amendment to the IGA to be executed by the Chair of the Pima County Board of Supervisors and attested to by the Clerk of the Board, and the RTA has caused this Amendment to the IGA to be executed by the Regional Transportation Authority of Pima County's Chair of the Board.




Figure 1 - Success Drive and Old Vail Road along Colossal Cave Road, between the UPRR Tracks
