**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

Pima Velo has requested the temporary closure of portions of Continental Road, Duval Mine Road, Helmet Peak Road and Mission Road for the Tucson Bicycle Classic on Saturday, March 18, 2017 from 5:00 A.M. to 1:00 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Continental Road, Duval Mine Road, Helmet Peak Road and Mission Road to enhance the safety of the Tucson Bicycle Classic event by reducing potential vehicular conflicts.
